



NOTICE OF THE PREPARATION OF PROPOSED VARIATION NO. 4 – CAMPING SITE POLICY, TO THE; WATERFORD CITY DEVELOPMENT PLAN 2013 – 2019 WATERFORD COUNTY DEVELOPMENT PLAN 2011 – 2017 and DUNGARVAN TOWN DEVELOPMENT PLAN 2012 – 2018

Notice is hereby given pursuant to Section 13 of the Planning & Development Acts 2000 as amended and Article 13 of the Planning and Development (Strategic Environmental Assessment) Regulations 2004 as amended and Article 6 of the Habitats Directive 92/43/EEC that Waterford City & County Council being the Planning Authority for Waterford City & County has prepared a Proposed Variation to the following Development Plans;

- Waterford City Development Plan 2013 – 2019
- Waterford County Development Plan 2011 – 2017
- Dungarvan Town Development Plan 2012 – 2018

The Proposed Variation seeks to introduce new policy provisions which reflect the contemporary and dynamic trends in the tourism accommodation sector, supports the on-going significant public investment in tourism infrastructure and broader public/private tourism initiatives and which protects and enhances the sustainability of existing settlements while safeguarding the natural, built & cultural landscape of Waterford.
