Economic Development Report to the end of September 2022

1. Rural Economic Development: Towns & Villages

Town Village Renewal Scheme 2020 Project works completed for

1.Clashmore.

- a. Installation of new kitchen & appliances in the Heritage Centre plus installation of large screen
- b. General building works including plastering, roof repairs, guttering, new windows, and doors for the Old School House, plus exterior drainage ground works and new steps to the building.
- c. Two new tourism signs for the public realm

2.Aglish

- a. Community Centre had an energy upgrade; works included installation LED lights, new fuse board, attic insulation, cavity wall insulation, new doors, fire alarm, disabled access ramp installed.
- b. Public Realm works, including traffic calming, directional and tourism signs.

3.Knockanore

- a. Installation of Remote Working facility for 6 persons created in the Community Hall, first floor space
- b. Bus shelter installed in village with associate path works.
- c. Tourism Heritage Signs installed at various points of interest and scenic route signs installed too.
- d. Marketing materials for the local Heritage Group to promote the KGK area and surrounding Blackwater Valley

Waterford Greenway

• A number of projects are currently being planned and/or implemented on Waterford Greenway with both WCCC funding sources and funding support from TII.

Dungarvan – Mallow Greenway Feasibility Study

- Public consultation period no. 1 closed end April 2022: https://www.corkrdo.ie/greenways/mallow-to-dungarvan-greenway/.
- Further stakeholder engagement continuing. Project team met with IFA reps at end June.
- Work progressing on study including route options and assessment, constraints study, flood risk analysis, structures report etc.

Waterford Trails

- Continuing to engage with Sport Ireland Outdoors and local trail development groups around Waterford with regard to ongoing monitoring, maintenance, development and promotion of Waterford's existing recreational trail network. Www.visitwaterfordtrails.com
- The DRCD have announced funding for Community Trail Management Organisations which is being administered at national level by Pobal. Five trail development groups in Waterford are eligible to apply for €1000, €2800 or €3000 depending on the length of the trail that the group manages and maintains. Funding announced will support purchase of equipment, small scale maintenance/repair or promotion of eligible trails. Eligible group in the Dungarvan-Lismore area includes the St. Declan's Way Steering Committee. Closing date for funding application 30th September.



4. Town Centre Footfall Data

Visitors to Dungarvan town centre

• The charts and points below relate to those classified as Visitors and not Passersby.

- In July and August 2022 the average daily visits were 1,100 and 971 respectively.
- The repeat visit rate for July was 85% and August was 84%.
- The median visit length was 27 minutes in July and 26 minutes in August, which is down on previous months.
- The largest grouping of visitors in July and August 2022 were classified as 'Weekly visitors'.



Note: Passersby are probing wireless devices detected by a Meraki Access Point (AP). While a passerby was seen by the network, its probes and dwell time did not meet the requirements to be considered a visitor. More detailed information on Visitors is provided below.



Level of Loyalty: Dungarvan town centre August 2021-August 2022

Explanatory Notes:

- Occasional visitors have visited at least once before. This visitor may have visited several times but does not meet weekly requirements.
- Weekly visitors have visited in at least two distinct weeks out of the past four, but not frequently enough to be considered daily visitors.
- Daily visitors have visited in at least five distinct days in the past eight.
- First time have never been seen before today.
