General

Minister Humphrey's issued an update to all Local Authorities regarding the delivery of the **Rural Development Investment Programme** during 2021. There are two new proposals 1. An additional €5 million funding for a Connected Hubs Call which aims to add additional capacity to the existing remote working infrastructure and 2. the DRCD will also be providing funding for the development of Town Centre Masterplans and would hope to have details of these proposals shortly.

3. Waterford Trails

Outdoor Recreation Infrastructure Scheme (ORIS) 2020:

As previously communicated, WCCC allocated €688,204 by DRCD in funding for 7 ORIS projects countywide. The following are the details of the Dungarvan/Lismore MD projects:

- Ballinacourty Greenway Spur upgrade. Subject to planning approval. Works to be completed by 31st Aug 2022.
- Owenashad River Walk: Works to be completed by 31st Aug 2022.
- The Towers Walk, Lismore: Works to be completed by 30th October 2021.
- Abbeyside Coastal Pathway: Works to be completed by 30th October 2021.

Outdoor Recreation Infrastructure Scheme (ORIS) 2019:

Work substantially progressed under all ORIS 2019 projects. Remaining Measure 1 and 2 projects to be complete by 31st August 2021 (following extension granted by DRCD due to Covid restriction related delays).

 Measure 1: Round Hill Walk, Lismore; EuroVelo Cycle Route and Waterford Cycling Trails signage upgrade works; Walk Waterford Promotion including new brochure, mapping, videography and photography.

- Measure 2: St. Declan's Way Works; Abbeyside Coastal Walk; Camper van parking area; Greenway play areas (30th November 2021 deadline for completion).
- St. Declan's Way (SDW): The SDW committee has formally applied to have the pilgrim route registered with Sport Ireland Outdoors (formerly the National Trails Office) with a planned official opening and launch in the first half of 2021, Covid dependent.

Cappoquin Amenity Hub

• WCCC in collaboration with the local community is currently in the process of preparing a brief to engage consultants for the feasibility, planning and design of a number of walking trail and Blueway amenities in the Cappoquin area. It is envisaged that consultants will be appointed shortly. This initiative is one element of the project being funded under Rural Regeneration and Development Funding (RRDF).

4. Tourism

Fáilte Ireland Platforms for Growth - Facility Centres for Water-based Activities Scheme

- Ardmore and <u>Tramore</u> have been approved under the Fáilte Ireland Platforms For Growth – Facility Centres For Water-Based Activities funding scheme.
- There are 22 sites across the country with a budget of €19million to 100% fund each building (this does not include works required outside the footprint of the building)
- Each centre will provide hot shower, changing and toilet facilities, secure storage, induction spaces, equipment washdown and orientation points.
- They will be fully wheelchair accessible and built using sustainability best practices such as solar heating panels to meet 'Nearly Zero Energy Building Standards'.
- Ardmore Site: the proposed site is in the existing car park, next to the sand castle building, and compensatory car parking will have to be secured to ensure the project can progress.

Indicative Timeline:

- May 2021: Compliance Phase 1 submitted
- Sept 2021: Compliance Phase 2 submitted
- Q4 2021: Funding approval by FI
- 01 2021: Detailed design
- Q2 2022: Planning Permission
- Q4 2022: Building
- Q2 2023: Facility Complete

5. Dungarvan Town Centre Management

Town Centre Footfall Data

• There was a small decrease in visitors (-3.7%) between March 2021 and April 2021.

- While there was a decrease in total visitors, the daily average visit length for April was 25 minutes which up slightly from 24 minutes in the previous month. There was also a small increase in those spending between 1-6 hours in the town centre indicating a longer 'dwell time'.
- The repeat visitor rate for April was 91.4%, down from 93% in March. The number of 'first time' visitors was up by 16.5% on the previous month.
