

Forbairt Eacnamaíoch / Economic Development

1. North Quays Infrastructural works

- a. Main contract. The main construction contract for the Waterford North Quays infrastructural works comprises the development of a Sustainable Transport Bridge, Transport Hub and SDZ Access Infrastructure Works is progressing, with tender documentation close to completion. It is expected the top five qualified submissions based on the recommendations of the Independent Assessment Board will be invited and proceed to stage 2 tender of the Restricted Procedure Process in April 2021.
- b. Planning applications. The preparation of a planning application for the western flood defence works is progressing, to be submitted to An Bord Pleanála in March/ early April 2021.
 Part 8 planning applications are currently being prepared by Kilkenny County Council for the Belmont Link road, N29 Port Road and enhanced greenway connectivity works. Detailed design for Abbey Road and Belmont Road Sustainable Transport Improvements is also progressing.
- c. **Advanced contracts/ enabling works.** Tender documents for the relocation of the Ferrybank Pump Station was issued on etenders 3rd February to be returned mid March 2021. Tender documents for the South Plaza Enabling Works and Rock Stabilisation contracts will be issued imminently.
- d. Ongoing contracts. The Utility Diversion as well as the Demolition and Site Clearance Works Contracts are both substantially complete and at final account stage. Transport Hub Independent Design Safety Certification by a Notified Body (NoBo) and Sustainable Transport Bridge Cat 3 Independent Design Check contracts are progressing. It is expected the construction works to the South East Greenway at Abbey road will commence once COVID-19 restrictions are lifted.

Local Enterprise Office Waterford announces online programme for Local Enterprise Week 2021

Waterford Local Enterprise Office has announced a programme of online events during Local Enterprise Week 2021, which takes place from March 1st to March 5th.

More than 200 virtual events are planned by the Local Enterprise Offices around the country and these include training workshops, information webinars and master classes with entrepreneurs and

experts, designed to help Ireland's small businesses and those looking to start a new business in 2021. "Initiatives like Local Enterprise Week are more important than ever as they showcase all the supports that are available to small businesses and start-ups now. As well as the ten 'Spotlight' events, we are offering a full programme of events over the five days of Local Enterprise Week" (Richie Walsh, Head of Enterprise at Local Enterprise Office Waterford).

Rural Economic Development

Outdoor Recreation Infrastructure Scheme (ORIS) 2019 and 2020

 Work under ORIS 2019 (Measures 1 and 2) and ORIS 2020 (Measure 1) progressing at locations throughout the county. All projects to be complete at dates between end February and end October 2021.

Dungarvan to Mallow Greenway Feasibility Study

• WCCC in collaboration with Cork County Council has recently issued a brief to engage consultants to undertake a feasibility study into the development of a Greenway in accordance with National Greenway Standards from Dungarvan to Mallow along the corridor of the former railway line from Dungarvan to Mallow. The Feasibility Report will examine existing infrastructure, identify potential alternative route options and recommend a preferred route along with a constraints report on the preferred route. It is envisaged that a consultant will be appointed in late Q1 2021 and feasibility report finalised in Q4 2021/Q1 2022.

Cappoquin Amenity Hub

WCCC in collaboration with the local community is currently in the process of preparing a
brief to engage consultants for the feasibility, planning and design of a number of walking
trail and Blueway amenities in the Cappoquin area. It is envisaged that consultants will be
appointed to the role in late Q1 2021. This initiative is one element of the project being
funded under Rural Regeneration and Development Funding (RRDF).

3. Communications & Marketing Unit Waterford 2040 Investment brand

Work continued throughout January and February to complete the branding material associated with the Waterford 2040 promotion plan. A workshop took place in early February with the members of the Economic and Enterprise SPC and a further workshop with the full Plenary Council also took place. An Executive Committee has been established and all brand material will be complete by Q2 2021.

Shop Waterford Support Local

Promotion of Waterford City and Town centre activity throughout COVID restrictions has continued via the Shop Waterford Support Local platforms on Facebook, Twitter and Instagram. Activity is lower since level 5 restrictions have prevented Click and Collect and concentration is now on promotion of online activity and continuation of awareness raising of the retail and hospitality sector offering in Waterford.


Internal Communication

Work is on continued improved in our internal communications is ongoing with the establishment of a "virtual" Internal Communications Group. The aim of the group is to identify

ways in which our internal communications can best aid and assist our communication with our customers, stakeholders, wider Waterford community and elected members. Use of Council IT infrastructure, including StoryMap and ArcGIS systems are being utilised.

4. Waterford Covid-19 Economic Recovery Plan

The Implementation Group are re-appraising the current plan in light of the recently published Revised Living with Covid Plan.



5. Tourism

Celtic Routes is a cross Irish Sea set of partners comprising of Carmarthenshire, Ceredigion, Wicklow, Wexford and Waterford City & County Councils and Pembrokeshire Coast National Park Authority have formed a partnership called "Celtic Routes" to deliver a tourism heritage project that will boost visitor numbers and spend.

These Coastal Counties in Wales and Ireland are unknown to a high number of tourists transiting the major arterial roads between entry points and the more well-known, 'tourism honeypots' beyond the target area. These locations on either side of the Irish Sea are characterised as transit routes and share several characteristics that present both challenges and opportunities for economic development.

The Celtic Routes Project has been developed to address the transitory nature by combining the natural, cultural and heritage assets in Ireland and Wales to increase visitor numbers (both day visitors and overnight) to the benefit of the economy in both Ireland and Wales. The project aims to harness the collective strengths of the regions, to maximise visitor spend and income retention to the local economies. The forming of this partnership is seen as a key new marketing opportunity. The long-term aim is to convert this potential tourism audience into new and repeat tourists.


The Project is partly funded by the European Regional Development Fund via the Ireland Wales Cooperation programme. To commence promotion for 2021 an advertising campaign aimed at creating awareness to travel when it is safe to do has been launched.

The Tourism Team is working closely with Visit Waterford and Fáilte Ireland to assist the tourism industry in dealing with their issues and challenges resulting from Covid 19.


Pleanáil / Planning

Planning Applications Received - Countywide

72 Planning applications were received in the month of February countywide (to 22nd February). This compares with 63 planning applications received in the same month in 2020. Additional responses are also being received to further information requests. A total of 127 planning applications were received in the year to 22nd February 2021. This compares to 114 planning applications which were received to the end of February in 2020



The number of applications which have been decided to date in 2021 has similarly increased. 138 applications were decided in January and February 2021 compared to 126 for the same months in 2020.



Pre Planning Update- Countywide

Pre-planning meetings are being undertaken where requested by telephone.

Update on preparation of the draft Waterford City and County Development Plan 2022-2028.

The draft development plan is currently being prepared for your consideration, having regard to the content of the Report of the Chief Executive and subsequent Direction by the Council to the Chief Executive, given in January. The timeline for preparing the draft development plan indicates that it will be presented to the Plenary Council in April as per the table below.

This will be followed by a series of discussions and workshops with the Plenary Council throughout the months of April, May and early June to allow full consideration of the draft development plan and associated documents. A 10 week phase of public consultation will then take place from late June to late August during which time written submissions will be invited from members of the public and other interested parties. It should be noted that written submissions regarding the zoning of land for particular purposes should only be made during this 10 week period.

In a manner similar to the initial phase of public consultation last summer, it is intended to have a dedicated online consultation portal available through which the draft development plan and support documentation can be accessed and through which written submissions can be made.

Planning SPC

The next meeting of the Planning SPC will be held on Tuesday 23rd March to progress their deliberations on the Draft City & County Development Plan.

Conservation

Waterford City & County Council has received 45 applications under the Built Heritage Investment Scheme (BHIS) and 10 applications under the Historic Structure Fund (HSF). These will now be assessed and the recommendations will be forwarded to the Department of Housing, Local Government and Heritage for approval

Waterford City & County Council has also applied to the Heritage Council for funding under the Historic Towns Initiative for Tramore

Waterford has the largest collection of medieval urban defences in Ireland with six intact towers, and over 700m meters of wall. The walls are an excellent heritage, educational and tourism resource and remain largely underexploited for the tremendous benefit they could offer the city. Rose Ryall, Conservation Officer gave a presentation to the Metropolitan district meeting with regard to the City Walls and Towers. She presented the findings of a report on access to and presentation of the City Walls and possible actions to help promote this heritage asset.

Closing date was Friday 26th February. Application forms are still being checked and logged. An allocation report will be sent to the members for the April meeting.

Comhairle na nÓg:

The young people continue to meet regularly using Zoom to progress their 2021 identified activities. All roles and responsibilities for the new Comhairle have now been allocated and work is continuing to build on previous progress.

Waterford Age Friendly Programme:

Thematic sub-groups continue to meet to progress the objectives of the AF Strategy. The OPC are actively engaged in the Community Response Forum and are also assisting in the Keep Well Campaign through the Stay Connected Programme providing valuable support to identified projects e.g. Nursing Home Tablets, AF photographic competition.

Healthy Waterford:

Funding received is supporting initiatives including active community initiatives, disability actions, social farming, and mental health.

PPN

JPC:

The next JPC meeting will be held on Monday 1st March at 5pm. Negotiations are underway with the Department of Justice to progress the proposed Local Community Safety Partnership pilot project for Waterford.

It is intended to launch the Waterford Migrant Integration Strategy 2021 -2024 in March, date to be advised.

SICAP

The Council have been working with a number of stakeholders to ensure SICAP services continue to be provided and to assist in putting in place experienced leadership and a new interim board for Waterford Area Partnership. A new board has been put in place and a senior executive of long standing experience shall assist the board with the process going forward.

<u>TIG</u>

The Waterford Traveller Interagency Group continues to meet regularly by way of Zoom. Needs Analysis being carried out.

St Patrick's Day Parade 2021, Waterford City and County

Waterford City and County Council was successful with an application to Fáilte Ireland for funding to develop and market St Patrick's Day as a tourism product. €25,000.00 of grant aid was awarded and the figure is being supplemented from the adopted Council budget with a further €30,000.00. The net effect here is a saving of €25,000.00 based on spending in previous years. A countywide greening programme where iconic landmarks such as the Metal Man in Tramore, the Viaduct in Kilmacthomas, Reginald's Tower in Waterford City and the Thomas Francis Meagher Bypass Bridge among many others will "go green". The programme aims to have an immediate uplifting impact on the community and help cultivate future tourism opportunities as Waterford looks to re-launch the hospitality industry post-Covid. Local, national and international media and promotional engagements are underway. An online Storymap will showcase each building and landmark when illuminated and offer some historical footnotes creating a unique piece of digital social history. A number of other community engagements, with health restrictions in mind, will provide families with fun activities in lieu of the cancelled parades including some photography and short story competitions. An online virtual parade where greening the house or garden, making a float and recording a short clip will provide for further public engagement on this important national day of celebration.



Environmental Education & Awareness

Litter Prevention - Waterford City & County Council continues to offer assistance throughout the year to the general public, community groups and schools to clean up litter and illegally dumped waste from their local environs e.g., approach roads, local beauty spots, beaches, and general public areas. These clean ups are ongoing. There has been an increase in the number of individuals &individual households carrying out clean-ups within their 5km limit at present, when groups cannot meet to carry out larger scale clean-ups as usual.

Anti-Graffiti and Anti-Litter Awareness Grant Scheme 2021 - Waterford City & County Council are currently inviting submissions for the Anti-Graffiti and Anti-Litter Awareness Grant Scheme 2021 from community groups, youth groups, schools, or other community development organisations, based in County Waterford, who are interested in receiving funding for initiatives regarding litter or graffiti. The main themes for projects this year will be to tackle dog fouling and roadside litter. Applications for projects under these themes will be prioritised for funding. Closing date for completed applications is 5pm 18th March 2021. Application and further details can be found on https://bit.ly/AntiLitterGrant2021

Waste Prevention Grant Scheme 2021 - The local Waste Prevention Grant Scheme 2021 has also been advertised with a closing date of 25th March 2021 and applications can be made at http://bit.ly/WastePreventionGrant2021. Both grants have been advertised on social media, the Council's website, in local newspapers and also through the PPN.

Anti-Dog Fouling Campaign - Work continues on the regional anti-dog fouling campaign with a launch date of 18th March. In the meantime applications for the Green Dog Walker programme have been reopened. This programme encourages dog owners to take the Green Dog Walker pledge. The Green Dog Walker scheme is a positive and pro-active way to encourage and support responsible dog ownership in Waterford. It aims to increase awareness of the problem of dog fouling which is among the most common forms of littering. When you sign up to the scheme we will send you a complimentary Green Dog-Walkers high-vis vest/armband and a 'doggie bone' poop-bag dispenser with a roll of bags. By signing up you have 'Taken the Pledge' to always clean up after your dog, to carry extra doggie bags and to gladly give others a bag for their dog if they ask for one. By wearing the high-vis vest you are indicating that you are a responsible dog-owner participating in and supporting the scheme. Over 500 Green Dog Walker pledges have been received to date in 2021.

Biodiversity Events - A webinar titled 'Bees, Birds & Trees - Biodiversity and Waterford Council' was held in which a presentation was delivered by Ms. Ella Ryan highlighting the efforts to support and promote biodiversity in the management of our Parks & Open Spaces. This event was well supported with over 100 people registering for the webinar which provided the public with information with regard to Waterford City & County Council's partnership with the All-Ireland Pollinator Plan. Due to the great interest in this event the possibility of providing a similar event later in the year is being examined.

Sustainable Gardening Course - A Sustainable Gardening course will commence in mid-March (dates to be advertised for applications shortly). Tidy Towns, community groups and community gardens will be prioritised and places will be limited. This will be advertised on-line and directly to these groups also.

Let Dandelions Bee - The "Let Dandelions Bee" campaign encourages the public to leave dandelions grow during March and April, instead of mowing them. This activity is in line with the aims of the All Ireland Pollinator Plan. By leaving Dandelions grow during March & April early pollinators such as bees

are provided with an early source of food. This is of great importance to pollinators and is a simple action that we can all take. A competition is being run during March and April to take a photo of your dandelions in bloom and photos can be emailed to letdandelionsbee@gmail.com

National Tree Week - This year's National Tree Week takes place slightly later this year from 21st – 27th March. Under normal circumstances, National Tree Week brings about the opportunity to promote tree awareness by engaging with communities, associations, workgroups and family groups get together and organise lots of tree planting events, making Ireland greener. This year we are mindful of Government restrictions to limit the spread of Covid-19 and accordingly only virtual events are being held to mark National Tree Week. Limited supplies of saplings have been allocated to Waterford City & County Council and these will be distributed to groups who had been allocated saplings in 2020 but were unable to avail of the saplings due to Covid-19 restrictions, etc.

Tidy Towns - The national Tidy Towns competition will go ahead this year, with groups encouraged to include relevant photographs wherever possible with their entries in case judging cannot take place in person due to COVID-19. Groups have also been encouraged to focus on biodiversity, green spaces and sustainable living. With this in mind, a webinar about planting for biodiversity was held for Tidy Towns groups on 10th February. This webinar included a talk by Consultant Ecologist, Botanist and National Tidy Towns Adjudicator Ms. Fiona MacGowan. It focused primarily on practical ways to enhance biodiversity locally. The webinar was well attended, with 29 attendees on the night. It provided numerous helpful tips and advice on the topic, as well as having a lively Questions and Answers session to finish. A copy of the presentation was sent to all participants afterwards. It also promoted gardening without the use of chemicals and 120 copies of our Greener Gardening guide were sent to various Tidy Towns groups for distribution to their local community following this webinar.

Two further on-line workshops have been organised for Tidy Towns groups following the success of this webinar; these will cover the topics of Sustainability & Sustainable Development Goals on 22nd March and also Tidy Towns Application Form Completion on 13th April (this will be especially important as the first round of judging will take place entirely based on applications this year). Invitations have been sent to all Tidy Towns groups for these events.

Green Schools - This year, Green Schools assessments are taking place online, in accordance with An Taisce recommendations. Green School Committees will continue to be engaged with via Zoom. However due to the extended closure of schools, engagement has understandably been much lower than usual for this time of the year. An Taisce has extended the assessment deadline until the end of the school year to reflect this nationwide trend. In an effort to continue to engage with schools, workshops are being offered online. Many teachers have expressed a preference for pre-recorded video content for workshops (due to internet connection, difficulty in scheduling anything live with a class at present, etc.) and so this content is being worked on in order to offer this option to schools also. Secondary schools are beginning to engage once again via online talks.

In February, all branches were closed to the public under Level 5 restrictions; staff commenced a book delivery service for schools and vulnerable patrons which has seen 1,475 items issued for 186 deliveries to households and schools. Arts Report

The Arts Offices continues to provide an arts service to artists, arts organisations and the community as a whole especially in the areas of Grants, Bursaries and Festivals supports and advice.

- Mentoring, advice and close contact with arts groups continued throughout February
- The Arts Office also worked on a number of partnership fronts within the Council and especially within the Culture Team. This included developing projects for the building resilience/keep well programme in literature, painting and graphic representation as well for other projects e.g. St Patrick's Day Programme and making time for social contact with artists.
- Council programmes in Arts in Health, Literature and Education continued along with Dance, Theatre, Youth and technology.
- Planning for International Womens Day in March, Poetry Day Ireland in April and Bealtaine Celebrating Creativity as we Age in May is underway as well as for Culture Night in September. At the moment programmes are being developed as on-line offering but with the option for limited public interaction is also being built-in should things improve.
- Partnership negotiations opened with publishers New Island Books for the printing and marketing of two volumes of new Plays from the South East that are currently being edited by Playwright Gary Mitchell.
- While the Waterford Gallery of Art remained closed one of the community rooms had a Green Screen built and hung and is waiting electrical and internet streaming works prior to commissioning. Maintenance continued on the Gallery as a whole including Artworks management. Preparations

continued for acquiring a storage facility for Waterford Art Collection – it is now at contract stage. Internal works and outfitting (design) will commence shortly.

- GOMA Waterford, with a grant from the Arts Council, realigned their Arts Garden so as to increase Covid-safe people spacing for their schools and outreach programmes. GOMA's artist's studios remained open but with restricted Covid-safe attendance. GOMA's delayed 2020 WIT Student exhibition came down with the help of volunteers. Incidentally the Waterford Art Collection's 2020 WIT bursary went to Marika Manning.
- Rogue Gallery's shop window on Michael Street was updated to reflect the current times. Meanwhile work continued in drawing-up plans for their section of Thomas Street House.
- Music Generation continued its programme with young people via digital platforms.
- ArtLinks Bursaries are currently open for artists in all disciplines to apply for support for them to develop professional development opportunities. Closing date is mid March.
