## Forbairt Eacnamaíoch / Economic Development

### **North Quays**

Waterford City and County Council is in active dialogue with potential developers, the Ireland Strategic Investment Fund (ISIF) and the Land Development Agency in respect of the North Quays SDZ site and intends to progress a proposal to conclusion in the coming months.

#### **CONTRACTS**:

The returned tender for the North Quays main construction contract; this includes the construction of the Sustainable Transport Bridge, the Transport Hub and Access Roads, has been assessed by the Project Assessment Board. The Final Business case for the North Quays project and the Assessment Boards recommendations have been submitted to Department of Housing Local Government and Heritage for cabinet approval as part of the Public Spending Code Gateway 3 approval.

Rock stabilisation works adjacent to Plunkett Railway Station and the South Plaza enabling works are ongoing.

David Walsh Civil Engineering has been appointed for the relocation of Ferrybank pump station, works are due to commence in the coming weeks.

Tender for the Pump station enabling works contract is currently being assessed by Roughan O'Donovan Consulting Engineers.

On 17th August WCCC forwarded a submission to An Bord Pleanála, as requested by the Board, for the western flood defence planning application.

Mallwood Ltd has been appointed for footpath widening on Abbey Road, works are due to commence imminently.

Local Enterprise Office launches first Waterford Digital Awards
Waterford Local Enterprise Office, together with Waterford City and County Council are hosting their first Waterford

The Awards aim to recognise and reward SMEs based in County Waterford who have developed their ecommerce and digital platforms as part of their product offering. The Awards are open to all businesses with less than 10 full time employees based in County Waterford.

Each category will have up to four shortlisted entrants who will be selected after an evaluation of their website/social media platforms by independent expert judges.

#### OUTDOOR RECREATION INFRASTRUCTURE SCHEME (ORIS):

#### WATERFORD GREENWAY

A number of projects are currently being planned and/or implemented on Waterford Greenway with both WCCC funding sources and funding support from TII.

#### **GREENWAY FEASIBILITY STUDIES**

Continuing to work with Cork County Council and Atkins Ireland with regard to the Dungarvan to Mallow Greenway feasibility study. Initial public consultation phase closed in April 2022. Further landowner, stakeholder and public engagement will take place at emerging preferred route stage in coming months.

Working with Tipperary County Council with regard to feasibility study into a Waterford Greenway to Suir Blueway Connection. A non-statutory public consultation period with regard to the study area opened on 31st August and will close for comments and observations on 7th October 2022.

#### WATERFORD TRAILS

Continuing to engage with Sport Ireland Outdoors and local trail development groups around Waterford with regard to ongoing monitoring, maintenance, development and promotion of Waterford's existing recreational trail network. www.visitwaterfordtrails.com.

The DRCD have announced funding for Community Trail Management Organisations which is being administered at national level by Pobal. Five trail development groups in Waterford are eligible to apply for €1000, €2800 or €3000 depending on the length of the trail that the group manages and maintains. Funding announced will support purchase of equipment, small scale maintenance/repair or promotion of eligible trails.


#### PLANNING APPLICATIONS RECEIVED - COUNTYWIDE

68 Planning applications were received countywide in August 2022 up to and including 26th August 2022. This compares with 67 planning applications received for the same period in August 2021. In July 2022, 96 planning applications were received in the full calendar month, compared to 116 received in July 2021.

A total of 742 planning applications were received in the year to 26th August 2022. This compares to 804 planning applications which were received to the 26th August 2021.

#### **PLANNING DECISIONS**

654 applications were decided from the 1st of January to 26th August 2022 compared to 717 for the same period in 2021. Of the 654 decisions, 553 decisions were granted and 101 decisions were refused.



## FORWARD PLANNING SEPTEMBER PLENARY REPORT REVIEW OF DEVELOPMENT CONTRIBUTION SCHEME

Following the provisions of Section 48 of the Planning and Development Acts 2000, as amended, we are currently reviewing the Development Contribution Scheme and intend to bring this to the plenary council over the period to the end of 2022. We will engage with the Plenary Council in the period prior to publication of the draft scheme and will utilise the consult.waterfordcouncil.ie portal for the purposes of broader engagement with members of the public and other relevant consultees once the draft scheme has been prepared. Following the period of public consultation, we will prepare a Chief Executive Report summarising details of written submission received on the draft scheme and setting out any amendments to the draft scheme where relevant. The Plenary Council will then have a period of 6 weeks to consider the content of the CE Report and the draft scheme prior to making the new scheme on or before 12th of February 2023. A broad timeline for the preparation of the scheme is set out hereunder.

#### Heritage Week

The return of in person and on-site Heritage Week events this year was a great success with over 51 events across the city and county. Great attendances were recorded at all events.

#### **Decade of Commemorations**

Research is almost complete for the GIS Story Map on Civil War events in Waterford and a website is being developed which will host all material relating to the Decade of Commemorations Programme in Waterford from the past 8 years.

#### **Community Monuments Funding**

Waterford City and County Council were awarded an allocation of over €220,000 under the 2022 Community Monuments Fund to support 6 projects.

#### **CONSERVATION OFFICER REPORT**

#### **Built Heritage Investment Scheme (BHIS)**

Many of the projects granted €182,400 funding under the Built Heritage Investment Scheme (BHIS) 2022 are now completed. Projects include repairs to chimneys, roofs, thatch houses, windows and repointing of walls

#### Historic Structures Scheme (HSF)

The works for the 5 projects, which were granted a total of €339,755 funding under Historic Structures Scheme (HSF) will be completed by the end of September.

## Seirbhísí Pobail / Community Services

#### **RURAL DEVELOPMENT PROGRAMME:**

- •The payments out on all LEADER Projects are progressing well.
- •One application for non-works project has been evaluated in June.
- •The last wrap up call has been brought forward to the 6th of July 2022.
- •The budget is small. €159,000 for Transitional LEADER and €3,000 for EURI Projects.
- •On existing projects, there are no decommitments and all are proceeding as planned.
- •Consultations for the next programme will commence this Autumn.
- •Payments out on completed projects will continue into 2023.
- •WLP has commenced initial work on Biodiversity and sustainability projects with communities and businesses.

#### **COMHAIRLE NA NÓG:**

Progress on 2022 activities is being made weekly by the young people and these are reviewed regularly by the steering committee members. Phase one and phase two of the multi-annual tree planting programme has been completed at the WIT Arena and in Cherrymount This activity is in partnership with WCCC, WIT and the Lions club. Meetings are ongoing to identify additional sites with engagements taking place with the trails officer in WCCC.

#### WATERFORD AGE FRIENDLY PROGRAMME:

Work continues through the Thematic sub-groups to progress the objectives of the AF Strategy.

Preparation of the new strategy document continues. The consultant is moving ahead with the consultations with engagement with thematic subgroups ongoing. An online survey has been developed for circulation and further public consultations are planned for September.

#### **HEALTHY WATERFORD:**

Healthy Waterford Committee met on the 18th of August to conduct an initial mapping exercise of the different projects under the Healthy Ireland fund to continue preparations for the rollout of Round 4 and enhance the relationships between Sláintecare, healthy communities & active cities . A further meeting to develop the strategic committee will take place on the 5th of September were the terms of reference will be drafted and discussed. The recruitment of a Healthy Waterford Coordinator has been completed with Eoin Morrissey being appointed on the 8th of August.

### SLÁINTECARE HEALTHY COMMUNITIES PROGRAMME (SHCP):

The Council through the LCDC has been tasked with the oversight and implementation at local level of elements of the Sláintecare Healthy Communities Programme. These include the employment of a SHCP Local Development Officer; the setting up of a SHCP Local Implementation Team (LIT) which has commenced and the Enhancement Funding Scheme. An application for €250k funding was successful and 4 projects have been completed under the programme. Update:

- •A mapping exercise took place to set up the Local Implementation Team and to agree on the ways we can work together in the wellbeing area.
- •2 out of the Enhancement Funding Scheme project were completed and work will start soon on the other two.
- •Ongoing consultations with community and other organisations regarding the needs or gaps in services.
- •The set up of a 'workers group' in the area of wellbeing with the role of identifying community projects that can be done in partnership.

#### **LOCAL COMMUNITY SAFETY PARTNERSHIP:**

The public consultation phase of the Community Safety Plan was launched on 29th June 2022 and details will be circulated to all members. Hub Planning were the successful tenderers for the development of the CSP and were a ppointed at the start of June. Waterford LCSP made four applications under the Community Safety Innovation Fund, applicants will be informed in August.

#### **UKRAINIAN COMMUNITY RESPONSE FORUM:**

The Ukrainian CRF is in place to assist with housing, supporting and integrating Ukrainian refugees into our communities. To date over 750 Ukrainian refugees have been accommodated in our Rest Centres in Dungarvan and Waterford City with 530 exiting, of which 350 were matched with pledged accommodation by Waterford Council staff.

#### PRIDE OF PLACE:

Waterford's main entry for the 2022 competition is the Surprise Group having won the 2021 PPN awards with the Housing Department entry being the An Garran estate in Tramore. Judging is taking place on Monday August 29th.

### **Social Inclusion:**

#### **MIGRANT INTEGRATION:**

Various initiatives being followed up on to progress the Strategy adopted by Council in 2020.

#### SICAP:

Work is ongoing with Waterford Area Partnership continuing to implement the SICAP programme on behalf of the LCDC with 79 local community groups and 953 individuals in Waterford expected to benefit in 2022.

SICAP Budget allocations for 2022 have now been confirmed and the budget for Waterford City & County (24-1) is €1,280,970.

#### TIG:

The Waterford Traveller Interagency Group continues to meet regularly by way of Zoom.

#### **NATIONAL PLAY DAY 2022:**

The Council has received formal approval from the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media for the allocation of €245,371 for the Regional Sports Centre to upgrade the floodlights to UEFA standards and European Sport Lighting Standards.

### Circular Economy and Miscellaneous Provisions Act 2022

The Circular Economy and Miscellaneous Provisions Act 2022 has been signed into law by the President. What the Act does - The Act:

•defines the Circular Economy for the first time in Irish domestic law;

•incentivises the use of reusable and recyclable alternatives to a range of wasteful single-use disposable packaging and other items;

•re-designates the existing Environment Fund as a Circular Economy Fund, which will remain ring-fenced to provide support for environmental and circular economy projects;

• Introduces a mandatory segregation and incentivised charging regime for commercial waste, similar to what exists for the household market. This will increase waste separation and support increased re-cycling rates;

•provides for the GDPR-compliant use of a range of technologies, such as CCTV for waste enforcement purposes. This will support efforts to tackle illegal dumping and littering, while protecting the privacy rights of citizens:

•places the Circular Economy Strategy and National Food Loss Prevention Roadmap on a statutory footing, establishing a legal requirement for governments to develop and periodically update these 2 policies;

•streamlines the national processes for End-of-Waste and By-Products decisions, tackling the delays which can be encountered by industry, and supporting the availability of recycled secondary raw materials in the Irish market; and

•consolidates the government's policy of keeping fossil fuels in the ground – by introducing prohibitions on exploration for and extraction of coal, lignite and oil shale

#### THE NEXT STEPS:

Draft Regulations on the Single Use Disposable Cup Levy will go out for consultation this autumn, with a view to these taking effect before the end of the year. A public consultation on new regulations in respect of the End-of-Waste and By-Products decisions making processes will also go out for consultation later this year.

The Local Government Management Agency (LGMA) will begin preparing the Statutory Codes of Practice in relation to the use of CCTV and other Recording Devices that Local Authorities will have to abide by as when using these technologies tackle illegal dumping. The Codes of Practice will then be submitted to the Minister for final approval.

### **Solid Fuel Regulations**

New Solid Fuel Regulations have recently been approved by the Government and will come into force on the 31st October 2022.

#### WHAT ARE THE MAIN CHANGES IN THE REGULATIONS?

- 1. The new technical requirements for fuels have been set and are outlined below
  - •Coal products and manufactured solid fuels must have a smoke emission rate of less than 10 grams per hour. Manufactured part biomass products must have a smoke emission rate of less than 5 grams per hour. This is effectively the same as is currently in operation in low smoke zones. Traditional smokey coals cannot meet these requirements and as such a prohibited from sale.
  - •Coal products and manufactured solid fuels, including manufactured part biomass products, must have a sulphur content less than 2% by weight on a dry ash-free basis, and with effect from 1 September 2025, subject to a market assessment, have sulphur content less than 1% by weight on a dry ash-free basis. Again, this is similar to the current provision for these fuels but the limits are expected to be reduced over time.
  - •A new requirement is that fuel products which are 100% biomass products including, wood products and wood logs, supplied in units of two cubic metres or less, must have a moisture content of less than 25% from 2022 and less than 20% from 2023.
  - •Wood logs supplied in units of two cubic metres or more shall be accompanied by a notice containing the statement specified in the Schedule 1 of the regulations.
- 2.It will be prohibited to sell turf via the internet or other media, or from a premises or place used for the retail of food, fuel or other goods (including from shops, garages and petrol filling stations, fuel yards and public houses and other public places).
- 3.FPN's no longer apply due to legal issues it will no longer possible to issue FPN's
- 4. Online sales are now included
- 5.No ban on the burning of fuel is included to allow householders to use up any existing product they may have from before the regulations are introduced.
- 6. There have also been changes to the producer and retailer responsibilities.

#### **HOW WILL THE REGULATIONS BE ENFORCED?**

The regulations are made under the Air Pollution Act and as with the current regulations, the Local Authorities are primarily responsible for the enforcement of the new regulations within their functional areas. A contravention of a provision of these regulations is an offence under the Act and will be prosecuted under the Act.

### **Environmental Education & Awareness**

#### **WASTE PREVENTION:**

Waste prevention workshops will be held in libraries for both Heritage Week (August) and Reuse Month (October). The focus of these workshops is making a reusable food wrap that provides a natural alternative to plastic wrap. These wraps are a great way to start out on your waste reduction journey and offer an easy switch from plastic. Each participant can make their own wrap to take home with them and are encouraged to bring along any other waste prevention or recycling questions they might have. The workshop provides a forum to discuss reuse, composting and recycling as the wraps are being made. These workshops will take place in Lismore, Waterford city centre, Ardkeen, Tramore and Kilmacthomas. Waterford City & County Council have been working with 2GoCup to encourage the use of reusable cups at cafes. 10 cafes are taking part in a three month pilot initiative with deposit return reusable cups that cost €1 each (5 cafes along the Greenway and 5 in Waterford). It is hoped that these 10 cafes will then encourage other cafes to accept and move towards reusable cups.

#### **SCHOOLS:**

The Green Schools Seminar will be online this autumn as most teachers found this to be a convenient way to take part. Ms. Ella Ryan, Environmental Education & Awareness Officer will be available to visit schools or answer any questions that they might have, as will An Taisce's Green Schools team.

Waterford City & County Council are working with a further four schools and the Waterford Teachers Centre to continue the Climate Literacy programme with secondary schools this autumn. This is a 10- week Climate Literacy programme, focused on improving climate literacy and fostering behaviour change in schools. The course is developed to include teacher training, resources, and lesson plans. The teacher training is designed to equip teachers with the knowledge, attitudes, behaviours, and skills required to effectively and confidently deliver not only this course, but also across their curriculum subject as the course can complement any subject framework that has an environmental strand. After the training the teachers will then be able to deliver the course with as many groups of students as they wish. An in-person teacher training day will be held on 22nd August, with further online sessions taking place during September.

#### LITTER AWARENESS:

The Love This Place national public awareness campaign from Leave No Trace Ireland took place from the beginning of June to the end of August. It urged the public to play their part by acting responsibly when using outdoor spaces through raising awareness of our impacts and what we can all do to make a difference. The campaign began by prompting people to take a pledge to follow the Leave No Trace principles. This year, it focused on the impacts of littering, responsible dog ownership and fires. Waterford City & County Council has been using some of these messages across its social media to highlight local issues, adding local images and text where necessary.

The Mayor of the City & County of Waterford officially launched the Gum Litter Taskforce's gum litter education campaign on 9th August. The Gum Litter Taskforce (GLT) is an environmental initiative that was set up to develop and implement an awareness campaign to reduce gum litter. Supported and funded by the chewing gum industry, the GLT initiative has made improvements in relation to gum litter awareness and disposal behaviour over the last 14 years. The latest results of the National Litter Pollution Monitoring report showed the percentage of gum as a proportion of litter at 9.4%, down from 10.6% the previous year (2019). As part of the Gum Litter Taskforce the 'Bin It!' education programme will travel across the country and deliver 60 performances a year to primary schools nationwide. The 'Bin It!' school roadshow encourages students to responsibly dispose of litter, and particularly gum litter, through actor-led workshops.

#### **COMMUNITY CLEAN-UPS:**

Waterford City & County Council facilitates community clean ups throughout the year to clean up litter and illegally dumped waste from approach roads, local beauty spots, beaches and general public areas. We continue to supply bags, gloves and litter pickers to many of the groups taking part, as well as collecting the bags of litter afterwards.

### Ealaíona & Cultúr / Arts & Culture

### **Arts Report**

The Arts Service has been successful in gaining further funding under the LLPPS4 programme for professional performance and technical arts up until October 30th. The Arts service is also applying for funding under the Outdoor Performance Spaces to aid the improvement of Performance activities in the County.

Arts Practice Grants and Venue Grants go online this week with a closing date of October 3rd (5pm).





The Old Market House Arts Centre is in the final fortnight of the 'Aspects' exhibition. A new exhibition featuring portraits from the Waterford Art Collection will be installed later this month. In addition new works for 'Market 22' by artists from the region will also open. The final TuneFest free weekly lunchtime summer concert series concluded in the Arts Centre which provided quality traditional music for visitors.

Culture Night Lights, an external art installation by students of Ard Scoil na nDéise, Dungarvan will be take place on Culture Night, Friday 23rd September from 8pm to late. Also on that evening the winner of the national Molly Keane Creative Writing Award 2023 will be announced and read at an online event hosted on the Waterford In Your Pocket platforms.

In association with the Waterford Healing Arts Trust, Art at the Kitchen Table outreach to West Waterford continues. This enables clients to avail of one to one art sessions in their own homes plus they attend a group session weekly in the Old Market House Arts Centre, Dungarvan.

The Arts Office and the ArtLinks partners in Carlow, Kilkenny and Wexford is working with First Music Contact, the leading national music organisation for resourcing popular musicians and the independent music sector in Ireland. This new project aims to develop a way of offering equal access to professional development services to musicians all around Ireland as well as developing a framework for supporting artists at a local level. This project will offer a high level professional development series to musicians in these counties as well as creating an opportunity for musicians to give feedback on what local supports they need to develop their careers. At present a questionnaire has been circulated to identify the needs and is available on waterfordarts.com, this will be followed up with participating in a mentoring programme.

### Libraries

In July and August, the 12 branches of Waterford City and County Libraries celebrated Reading, Heritage and Culture. Our Libraries popped up in the community for three special occasions reaching out to new members and highlighting our excellent service.

#### LIBRARY DEVELOPMENT:

- •Waterford Libraries were awarded over €310,000 total funding for our My Open Library services.
- •Waterford Libraries were delighted to receive €33,597 in funding from the Dormant Accounts Fund which will allow us to extend and galvanise our commitment to literacy, numeracy and dyslexia services and to support the continuation of our Oral History project in West Waterford.
- •Two Library projects have been shortlisted for this year's Chambers Ireland Excellence in Local Government Awards on our Dyslexia Support Services in the Diversity and Inclusion category and on our intergenerational music project, 'The people we grow up to be' in the Age-Friendly Initiative category.
