Section 38 Road Traffic Act 1994 – Traffic Calming Scheme Faithlegg School- Improvement Works

Proposal

Waterford City & County Council proposes to undertake road improvement works at Faithlegg School, Coolbunnia, Co Waterford, as set out on the attached drawing. Works will include the widening and upgrade of the footpath adjacent and opposite to Faithlegg School, improved road markings, widening and reconstruction of the existing footpath and construction of a new push button crossing located outside the school entrance on the L4082 Cheekpoint Road.

The goal of this scheme is to achieve an improved pedestrian crossing point for children entering the school and encouraging children to walk to school with a safe crossing point from the locality.

Public Consultation

The proposal was advertised for submissions in the News & Star newspaper, the website, on social media and notified to An Garda Siochána inviting submission up to 15th June, 2021.

- 3. I have major concerns regarding the traffic speed approaching the proposed crossing from both directions. The council's stated goal is to ensure a safe walking passage for children to school. However the speed of vehicles on the stretch of road from Cheekpoint to Faithlegg church is not in concordance with this goal and in my opinion is a major hazard.
- 4. The footpath from Faithlegg Church to the school is extremely narrow in parts and with vehicles permitted to drive up to 60km/hr a small slip from a child would have catastrophic outcomes. Perhaps traffic calming measures along this stretch and protective barriers/bollards for the footpath could be considered.
- 5. Perhaps the council could consider appropriate designated parking to maximise space and safety along this short stretch.

Additional public lighting and signage will be installed as part of the scheme.

The provision of parking is a matter for the School and Board of Management.

Conclusion

The proposal as advertised and as set out above is recommended for your approval.
