Part II Pay Parking General 6 (1) (e)	Remove “This bye-law shall not apply to a pay and display ticket parking place where the pay and display parking ticket machine for that pay and display ticket parking place is temporarily suspended from operation save where another pay and display parking ticket machine is provided at that pay and display ticket parking place or pay by app is available”	Bye-law no longer required, sufficient number of alternative machines and other options available.

Disabled persons parking bay	Include addition to bye-law see text in red "A person shall not stop or park a vehicle, or cause such vehicle to be stopped or parked in a disabled person's parking bay, without having on display a valid disabled person's parking permit issued pursuant to Article 43 of the Regulations of 1997. The vehicle shall be parked for the convenience of the person to whom that permit was granted. A vehicle displaying a valid disabled persons permit shall not be parked for longer than is specified on the information plate, if any, or is a prohibited vehicle"	Campervans are currently prohibited from parking on the Prom in Tramore and this includes campervans parking in disabled parking bays displaying a disabled parking permit. This bye-law is being amended to allow enforcement of same.
Part VIII Miscellaneous 46. Non Application of bye-laws to specified vehicles No. (5)	Remove "(iv) a valid exemption permit"	Exemption permits no longer in use.
Part VIII Miscellaneous 46. Non Application of bye-laws to specified vehicles No. (7)	Insert new bye-law "An electrically powered vehicle while actively charging at a designated charging point"	Inclusion to specify charging of electric vehicles.
SCHEDULE 1 – Tramore	Insert "Any designated campervan site provided by the Council" Tariff J	To provide a charging regime for future designated campervan parking facilities.
SCHEDULE 1 – Tramore	Insert Turkey Road Tariff H	Inclusion of Turkey Road to locations schedule to allow enforcement, the tariff is Free.
SCHEDULE 2 Parking Ticket Fees	Amendment to Tariff F to include months "April, May"	To extend the pay and display parking by 2 months to include April and May to reflect the commencement of the busy summer season. No change to rate.
SCHEDULE 2 Parking Ticket Fees	Insert new tariff "H" Parking Fee Free Monday to Sunday 24 hours – no overnight parking for campervans between the hours of 22.00 to 08.00 Monday to Sunday. No maximum Stay.	To eliminate overnight campervan parking on Turkey Road and other locations as required.
SCHEDULE 2 Parking Ticket Fees	Insert new tariff "J" Parking Fee €15 for 24 hours Monday to Sunday April, May, June, July, August, September Maximum Stay 48 hours	To provide an overnight rate for campervans in designated parking spaces.
