Footpath Programme 2021

Last year it was agreed to make a four year provision of €800,000 per annum over a four year period to undertake a footpath repair and upgrade programme across the City and County in order to address a significant level of defects that have arisen in recent years.

2021 will see the first phase of this programme and it is initially proposed in this phase to prioritise repairs on those footpaths on the following basis –

- Footpaths where the Council has experienced levels of public liability claims arising from trip and fall accidents
- · Footpaths that have been badly damaged due to tree roots breaking through the path
- Footpaths that are visually in a very poor condition and where we have had numerous reps from the Members and the public
- Dishing of footpaths to enable wheelchair access at junctions

The initial priority list is on the attached schedule (1) and it is proposed to proceed to carry out these works commencing this summer and running through into the first half of 2022.

A further priority list will be created in early 2022 and brought to Council for consideration at that time.

In addition to this list, normal repair work and urgent works will continue to be delivered as part of the Road Works Programme.

This investment in footpath infrastructure also needs to be viewed in the context of a very significant level of investment in footpaths and cycle lanes in the Metropolitan Area under the Active Travel Programme.

In this context I am attaching on schedule 2 a list of some of those projects in the Metropolitan Area which are due to be delivered this year and this represents year 1 of a 5 year commitment from the National Transport Authority which will see significant increases in expenditure in active travel projects over the next 5 years. In addition to those outlined on Schedule 2, there is also a multi-million Euro funding commitment from the NTA in the current year to develop a range of cycling infrastructure measures (primarily in the City area) which will for example see commencement of the Bilberry to City Centre Greenway extension in the current year, detailed design for the WIT to City Centre cycle route, bus priority measures, design of cycle infrastructure measures for the Inner Ring Road, Dunmore Road and others and the design / tendering for a greenway between Ballindud and Tramore.
