

## Forbairt Eacnamaíoch / Economic Development

#### **North Quays**

#### 1. Funding

In November 2020 Waterford City and County Council was allocated €80,600,000 under the Urban Regeneration Development Fund and an additional €30,000,000 of funding was confirmed from the National Transport Authority. The €110,600,000 funding is for infrastructural works for the development of the North Quays Strategic development Zone site. It will enable the completion of the three key infrastructural elements and associated works which Waterford City and County Council are progressing as well as infrastructural works that are being progressed by Kilkenny County Council

#### 2. Current status on infrastructural works

- **a.** Detailed design for the Sustainable Transport Bridge, Transport Hub and SDZ Access Infrastructure Works are currently being finalised for issue in early 2021 and will form part of the Main Contract Works as outlined below.
- **b.** Detailed design drawings for tender documentation for relocation of the pump station are being finalised for issue.
- **c.** Rock stabilisation tender documents for the cliff face to the north of Plunkett Railway Station have been issued to WCCC for review and it is planned to go to tender in 2021.
- **d.** The preparation of a planning application for flood defence works is currently being progressed, to be submitted to An Bord Pleanála in March/ April 2021.
- e. Part 8 planning applications are currently being prepared by Kilkenny County Council for the Belmont Link road and enhanced greenway connectivity works. Detailed design for Abbey Road and Belmont Road Sustainable Transport Improvements will progress in early 2021.

#### 3. Tender processes and ongoing works

- a. **Main contract.** On 3<sup>rd</sup> June 2020 tenders were received for the Waterford North Quays Project Suitability Assessment Questionnaire (SAQ) for the Main Construction Works. Roughan O'Donovan (ROD), Consulting Engineers carried out a pass / fail assessment and an Independent Assessment Board carried out a qualitative assessed on the tenders received. BDO Ireland is finalising a financial evaluation on the top five tenderers as recommended by the Assessment Board. The top five qualified submissions based on the recommendations of the Board and financial analysis will be invited to stage 2 of the Restricted Procedure Process.
- b. Advanced contracts/ enabling works. The Utility Diversion Works Contract and Demolition and Site Clearance Works Contract are both substantially complete and due to be off site before Christmas. Consultant appointment to undertake the Transport Hub Independent Design Safety Certification by a Notified Body (NoBo) is due in early December while Hewson Consulting Engineers has been appointed for the Sustainable Transport Bridge Cat 3 Independent Design Check contract. Both contracts are expected to commence in the coming weeks.
  - Works are progressing raising sleepers and track on the South East Greenway, between Waterford and New Ross.

#### 3. Rural Economic Development

- Town & Village Renewal Scheme 2018 to be claimed in November 2020
- Town and Village Renewal Scheme 2019 5 applications are progressing as per DRCD requirements.
- Town and Village Renewal Scheme 2020 Expression of Interest Process for TVRS 2020 completed with applications submitted for 9 applications in September 2020.
- Town & Village Renewal Scheme Accelerated Measure 2020 -16 projects are being progressed where allocations have been made.

#### 4. Tourism

• Funding of €30,000 was secured from Fáilte Ireland for Illuminate Waterford at Winterval. Waterford was one of only two Councils (Cork was the other) successful in securing this funding from FI.

## Waterford Trails ORIS 2019

All projects progressing well. Measure 1 projects due to be completed by year end. Measure 2 projects due to be completed during 2021.

#### **ORIS 2020**

Applications for funding under Measure 1 submitted end September. Applications under Measure 2 and 3 submitted on 30<sup>th</sup> November.

#### **Greenway Feasibility Studies**

- WCCC in collaboration with Cork County Council is currently preparing a brief to engage consultants to undertake a feasibility study into the development of a Greenway in accordance with National Greenway Standards from Mallow to Dungarvan along the corridor of the former railway line from Mallow to Dungarvan. The Feasibility Report will examine existing infrastructure, identify potential alternative route options and recommend a preferred route along with a constraints report on the preferred route. The brief is expected to be completed and issued shortly. It would be envisaged that a consultant could be appointed in Q1 2021 and feasibility report finalised in Q4 2021/Q1 2022.
- Currently preparing brief to engage consultants to undertake a route assessment and feasibility study into the development of a Greenway from Waterford City to Tramore.

#### 5. Economic Development

#### Waterford Council's URDF Application: City Centre Revitalisation

The proposed timeline for the project is 2020-2027, with a total cost of €48,550,285 (€27.6m is being sought from the URDF). The application supports the continuation of an ongoing public works programme which will deliver Waterford as a regional city of scale and premier urban centre in the South East Region.

#### **Objectives**

#### (i) Provide affordable, diverse and suitable mixed use buildings

The project identifies infill and regeneration opportunities to intensify residential and employment development throughout the city centre by capitalising on and continuing with city centre regeneration works carried out over recent years.

#### (ii) Green Transformation

Waterford will be the centre of a green transformation connecting the City to the region by a network of 3 major greenways. These are the existing 47 kilometre Waterford Greenway, the 26 kilometre Kilkenny Greenway and the 56 kilometre Wexford Greenway. There will be a 10 kilometre greenway linking Waterford to Tramore. In all, 150 kilometres of greenway will intersect in the heart of Waterford at the new sustainable transport bridge.

#### (iii) Create a Walkable City Centre

The city is a complex continuum of streets and spaces, but many previous functional uses that gave order to the city areas have decayed or moved away. Therefore, it is helpful to synthesize or consolidate zones that can be given special identity in order to give a new creative framework and vibrancy to the city centre. These zones can then be the subject of focused attention and planning.

#### (iv) Resilient/ Smart GovLab

The focus of Smart Cities and Communities initiatives involves exploiting the most advanced communication technologies—in particular in the areas of energy, transport and ICT - to support added-value services for the city, community and citizen. It is proposed to make significant advances in the short to medium term to reorienting the City as a Smart City. The city centre in the first instance will give expression to Waterford's identity

as a modern, dynamic, innovative Smart European city in that the current proposal involves a bold attempt at redeveloping the city's Cultural Quarter as a Smart Street with enhanced infrastructure and re-purposed buildings in support of redefining Waterford as a Smart City.

#### (v) Economic Development & Enterprise SPC

The Economic Development & Enterprise SPC met on November 2<sup>nd</sup>. The SPC were briefed on the Retail Strategy and agreed the revised draft Casual Trading Byelaws.

#### **Communications & Marketing**

#### Waterford 2040

The Waterford 2040 website and investment prospectus are at final design stage and will be presented to an Executive Group in early January with a view to a Q1 2021 launch date. A detailed marketing plan to promote Waterford as an attractive location for inward investment and development will be finalised for 2021 -2022.

#### **Keep Waterford Safe**

Waterford Council is continuing to work in partnership with WLR FM and a number of industry partners to raise public awareness of the measures required to help prevent the spread of COVID 19 and reduce the incidence rate. A range of measures include radio advertising, social media awareness raising, video competition and a Keep Waterford Safe face covering.

#### **Shop Waterford Support Local**

The Communications section continues to promote the Shop Waterford brand through its social media channels, through WLR sponsorship and promotion of the Waterford Chambers' Shop Local voucher scheme. A meeting was facilitated with retailers across Waterford to inform the campaign and bring on local support and brand ambassadors.

Of the 33,580 people reached during 22<sup>nd</sup> October to 18<sup>th</sup> November, 50% were located in Waterford and 7% in Dublin which supports the aim of promotion Waterford as a retail destination of choice to audiences outside Waterford and the South East region. This audience will be targeted specifically when nationwide travel is permitted.

#### Covid-19 Economic Recovery Plan – Report to Plenary Council – December 2020

- Waterford Council has paid over €11.5m to local companies under the Re Start Grant, RSG Top Up and RSG+ with an average value of €4,502.
- Waterford LEO approved 592 local SMEs for a Business Continuity Voucher totalling €1.4m.
- 378 businesses successfully applied to Waterford LEO for a Trading on Line Voucher (TOV) totalling €881,176.
- 3 Waterford companies were funded under Enterprise Ireland's Covid Online Retail Scheme with an average national grant of €36,700.
- 25 applicants were supported in their applications to Micro Finance Ireland in the amount of €503,420.
- 583 businesses availed of Waterford LEO's Covid Mentoring supports and 1,566 availed of Covid training. This is separate to those that would have availed of similar supports provided by Waterford Chamber and Dungarvan & West Waterford Chamber.
- Waterford Council waived the annual S254 licence fee for outdoor seating for 60 local businesses.
   Outdoor seating was also supported through an Outdoor Seating Grant where 33 applications totalling €46,197 have been approved.
- €140,000 was secured through Towns & Villages funding designed to assist towns and villages in recovery effort from Covid-19 under 3 calls in July & August.
- The Shop Waterford Support Local campaign was launched in May which in addition to a strong online presence in partnership with waterfordfyi.ie, has also included print media features and WLR radio


advertising. The campaign is being rolled out in partnership with Waterford Chamber and Dungarvan & West Waterford Chamber. The campaign has also focused on encouraging the uptake of Shop Waterford vouchers.

- eWaterford.com e-commerce platform developed and now managed by Waterford Chamber.
- Local Tourism Recovery Taskforce established with Failte Ireland and domestic tourism campaign developed for 2020. A review of 2020 is currently taking place which will inform plans for the 2021 campaign.
- €30,000 funding was awarded by Failte Ireland under the Reignite Programme for 'Illuminate Waterford'.



#### Footfall – Dungarvan town centre (system went live 28.08.20)




#### **Review of Covid-19 Economic Recovery Plan**


A review of the Economic Recovery Plan is currently ongoing and a number of stakeholder groups have already been engaged with to date including the city and town centre management groups and the Economic Development & Enterprise SPC, Tourism Recovery Taskforce and Industry Grouping. An updated version of the Economic Recovery Plan will be available in December.

## **Pleanáil / Planning**

#### Planning Applications Received - Countywide

82 Planning applications were received in the month of November countywide (to 29<sup>th</sup> November). This compares with 82 planning applications received in the same month in 2019. Additional responses are also being received to further information requests.





#### **Pre Planning Update- Countywide**

Pre-planning meetings are being undertaken where requested by telephone.

#### **Development Management**

All technical staff have been provided with laptops and are currently working from home with minimal visits to the office (usually outside normal office hours). All planning applications are scanned to iDocs so that Planners

can review applications remotely without having to be provided with a hard copy. Reports are forwarded by email and contact between planning staff and their line managers is now generally taking place by telephone rather than face to face.

Waterford City & County Development Plan 2022 – 2028 (Chief Executive Report). Area based in-person workshops to discuss the Chief Executive Report on pre-draft development plan public consultation.

Following on from the discussion at the November Plenary meeting, a series of in-person workshops with Elected Members is taking place during December to identify any queries arising with regard to the Chief Executive Report or any specific issues which may inform any direction to the Chief Executive.

As stated previously following consideration of the Chief Executive Report, the Members of the planning authority may issue directions to the Chief Executive regarding the preparation of the draft development plan, and any such directions shall be strategic in nature, be consistent with the draft core strategy, and shall take account of the statutory obligations of any local authority in the area and any relevant policies or objectives for the time being of the Government or of any Minister of the Government. Section 12 (18) of the Planning and Development Act 2000, as amended, states – "statutory obligations' includes, in relation to a local authority, the obligation to ensure that the development plan is consistent with—

- (a) the national and regional development objectives specified in—
  - (i) the National Planning Framework, and
  - (ii) the Regional Spatial and Economic Strategy, and
- (b) specific planning policy requirements specified in guidelines under subsection (1) of section 28."

In issuing directions, the Members shall be restricted to considering the proper planning and sustainable development of the area to which the plan relates.

strategic issues for the draft development plan, including MASP implementation and on informing a response to the Review of the National Development Plan (consultation closing on 29<sup>th</sup> January).



#### **Woodstown Viking Site**

An application for heritage interpretation artwork has been submitted to the Community Monuments Fund under the Department of Culture, Heritage and the Gaeltacht. Funding was obtained under the Creative Ireland Programme for design of a heritage information panel for the site.



#### **Tramore Wildlife Signage**

A series of 5 information panels have been

installed in Tramore Nature Park and Estuary Road in Tramore celebrating the wildlife interest of the area and have been received very positively by local Tidy Towns and Eco Groups.



#### **Community Monuments Fund**

Waterford City and County Council were allocated €10,500 for conservation works at Knockboy Medieval Church and a Conservation Management Plan for St. Declan's Well Ardmore under the Community Monuments Fund from the National Monuments Service of the Department of Housing, Heritage and Local Government.



## **Bóithre agus Iompar / Roads and Transportation**

#### **July Jobs Stimulus Projects**

A very ambitious programme of works was undertaken by each of the Engineering Districts under the 3 Stimulus Project Schemes announced in July. Projects were delivered by a combination of Machinery Yard direct labour and Contractor works within a very tight timescale, in challenging conditions and restrictions. The majority of the projects have been completed at this stage and the remainder will be finalised within the next few weeks. Funding in respect of a small number of projects have been approved for transfer into 2021 and these projects will form part of next year's work programme. Overall the Roads Department expects to draw down the full allocation of over €4.2 million.

#### **NTA National Transport Authority Funding**

Funding provided for projects at various locations throughout the City to support pedestrian and cyclist movement and to enhance accessibility. Over 20 schemes have been provided throughout the City and the funding was targeted at supporting our response to Covid-19 challenges and assist with our work to equip local communities and businesses with improved walking and cycling infrastructure. The funding also allowed for changes to traffic management arrangements to facilitate the reallocation of overall road space to improve facilities and safety for pedestrians and cyclists. #### **Compulsory Purchase Orders**

In compliance with the Council's Vacant Homes Action Plan, Waterford City & County Council have an ongoing programme to deal with property vacancy that currently involves sixteen (16) Compulsory Purchase Orders that target twenty (20) individual properties. So far, all sixteen (16) of these Compulsory Purchase Orders have been confirmed by An Bord Pleanala. These properties have all been identified as vacant, in private ownership and are located countywide. It is proposed to extend the initiative to reduce vacancy to all areas of the county.

## Seirbhísí Pobail / Community Services

#### **Rural Development Programme:**

- LCDC approved €57,000 in funding for four projects at the November Meeting.
- For the December LCDC meeting, there will be another four applications. Total value of €315,000 which will ensure the punctual and full allocation of of the available budget for the programme.
- Payments to projects already commenced is proceeding. €3.4m paid out to date. €600,000 due to be paid out over the coming months.
- Construction now commencing on the first of a number of Smart Working locations in four West Waterford villages Tallow, Lismore, Cappoquin and Villierstown to create the Blackwater Valley Economic Development Zone.

#### Community Enhancement Programme - Community Centre & Community Buildings

All 41 successful applicants have received their grant allocation.

#### **Community Mental Health – Small Grant Scheme**

The 9 successful applicants have received their first instalment of their grant allocation.

#### COVID-19

#### Emergency Fund

Waterford Council received €73,177 from the Department of Rural & Community Development under this fund, which has now been fully allocated. Community groups who are involved with Waterford Covid 19 Community Call are eligible to apply for this fund. 42 groups have received funding, with 11 of those groups receiving an additional allocation.

➤ €67,225 allocated to WCCC under Healthy Ireland Fund towards Covid 19 "Keep Well" campaign.

#### Comhairle na nÓg:

The young people continue to meet regularly using Zoom. The AGM was held via Zoom on Saturday November 28<sup>th</sup> and was a great success with a lot of membership interest from young people across City and County. The funding application for 2021 and annual report/return to the Department is currently being prepared.

#### **Waterford Age Friendly Programme:**

Most thematic sub-groups have now restarted following Covid 19 with initiatives/projects identified progressing again. The OPC are actively engaged in the Community Response Forum and also assisting in the Keep Well Campaign through the Stay Connected Programme providing valuable suggestions of potential projects that could be undertaken.

#### **Healthy Waterford:**

Funding received is supporting initiatives including active community initiatives, disability actions, social farming and mental health.

#### PPN

714 groups registered with the PPN: 574 Community pillar; 115 Social Inclusion pillar; 25 Environment pillar.

#### JPC:

The next JPC meeting will be held on Monday 7<sup>th</sup> December via Zoom.

County Waterford has been selected as a pilot location for the Local Community Safety Partnership. It was selected based on a number of factors, including population density, crime rates and deprivation. The pilot Local Community Safety Partnerships will replace the existing Joint Policing Committees. They will also provide a forum for accountability in relation to local policing plans. Each pilot will run for 24 months. Awaiting further information from the Department of Justice.

#### **Social Inclusion:**

#### **SICAP**

Covid 19 has had an impact on the operations of the Programme Implementer, Waterford Area Partnership. WAP have engaged with the Community Response Forum, Waterford Food Bank, the Roma and Traveller Communities and other minorities to support Covid 19 responses. Support has been given to 26 groups to assist with completing Risk Assessments re Covid 19 and WAP are continuing to work with Waterford Volunteer Centre.

Progress on engaging with and animating community and voluntary groups remains strong, but working with individuals has proven to be more challenging, as could be expected.

#### <u>TIG</u>

The Waterford Traveller Interagency Group continues to meet regularly by way of Zoom and the last meeting was on December 2<sup>nd</sup>. Needs Analysis being carried out



Environmental enforcement officers continue to investigate complaints received and monitor illegal waste issues, littering, dog fouling, fly-tipping, and illegal signage and issued litter fines where offences are detected. The Waterford City & County Councils Dog Wardens continue to investigate all dog control issue throughout the City & County.



#### **Draft Litter Management Plan 2021-2024**

Advertisements have recently been published & broadcast on local radio to advise that Waterford City & County Council propose to replace the current Litter Management Plan and has prepared the Waterford City & County Council Draft Litter Management Plan 2021-2024.

A copy of the Waterford City & County Council Draft Litter Management Plan 2021-2024 is available on the www.waterfordcouncil.ie website.

Written submissions in relation to the Draft Litter Management Plan 2021-2024 are invited by Waterford City & County Council and will be taken into consideration by the council before the plan is made and implemented. The closing date for receipt of written submissions is 4pm on the 11th January 2021.

#### **Environmental Education & Awareness**

#### Waste prevention

As part of "Waste Awareness Week" Waterford City & County Council hosted a virtual waste roadshow from the 23<sup>rd</sup> to the 29<sup>th</sup> November. This event included a website & social media account take-over, virtual workshops on recycling, textile upcycling, etc. – the topics were: Recycling, Household Hazardous Waste, Reuse of Textiles, Food Waste and a video of some of our recycling facilities. Traditional media articles included radio & print press, advertisements on WLR FM for the week. WLR FM played an interview on the news bulletin and the morning show also interviewed Renew Enterprises, a social enterprise that repairs and sells lawnmowers and bikes.

The themes for the week were as follows:

Monday, November 23: Recycling. Social media posts, recycling explained via video, a local video of recycling facilities and a virtual Schools workshop on recycling with Presentation Primary School

Tuesday, November 24: Greener Cleaning – video on how to clean using non-hazardous ingredients, social media posts and link to resources

Wednesday, November 25: Food Waste – video on how to reduce food waste at home, social media posts

Thursday, November 26: Launch of our 'Paint Smarter' LAPN project, to include social media posts, a short video, tip of the day videos, point of sale information leaflets and stickers, etc.

Friday, November 27: Textiles –social media posts, video tutorials on how to repair clothing and an online workshop re textile upcycling workshop.

#### LAPN funding was recently granted by the EPA for two associated projects:

The first of these is a joint project with Carlow County Council and Kilkenny County Council (with Waterford City & County Council as the lead authority in this project) to prevent paint waste by raising awareness about top tips to purchase, store and dispose of paint to create least waste. The over-purchasing of paint has been an ongoing issue in Ireland and has particularly escalated during COVID 19. In previous hazardous waste collection days at our Civic Amenity Sites, we have noticed a significant collection of non-hazardous paints. In order to prevent wasted paint, we are raising awareness of how to calculate paint required, store paint, dispose of paint, etc. These tips are being shared online through social media posts and videos, on radio and at point of sale in hardware and paint shops. <a href="https://vimeo.com/481622966/6a89c369dc">https://vimeo.com/481622966/6a89c369dc</a>

The second project receiving funding from the EPA is a feasibility study to assess the viability of establishing a paint reuse social enterprise in Co. Waterford working through one of our Civic Amenity Sites. We are currently exploring this with a social enterprise based in Waterford.

#### Litter

Waterford City & County Council continues to offer assistance throughout the year to the general public and schools to clean up litter and illegally dumped waste from their local environs e.g. approach roads, local beauty spots, beaches and general public areas. These clean ups continue throughout the winter months.

Waterford is taking part in the Picker Pals educational programme for primary schools. The programme engages children through a story world, with programme specific readers and activity books given to every child in the class. A "Picker Pack" is also provided which contains a child and adult litter-picking tool to be taken home by a different student every week. The family then go on a litter picking adventure in their local area with the child reporting their activity back to their classmates. When they return the pack, they are asked to talk about what they found, fill out worksheets on how they can prevent the littering of these items and come up with solutions. It aims to get children and their families looking at litter in their local environment and talking to classmates, family and neighbours about the issue.

#### **Schools**

School workshops have moved online for now and schools are beginning to take the opportunity to receive workshops and talks online now, particularly waste prevention and recycling workshops. Five schools have taken part in virtual workshops about recycling and waste prevention to date.

#### **Veterinary Services and Food Safety Update**

As the local authority veterinary service is considered to be an essential service, food safety surveillance inspections and meat inspection, slaughter and animal welfare audits, traceability and labelling audits have been ongoing throughout the Covid-19 pandemic in the 6 approved meat premises (3 slaughterhouses and 3 meat processing premises) and 3 registered meat premises under supervision in accordance with the service contract with the Food Safety Authority of Ireland (FSAI). All such duties are carried out in accordance with public health and government guidelines in relation to Covid-19 and specifically in accordance with Council SOP No.20 on LA Veterinary Inspector Covid-19 Requirements- May 2020 developed for the local authority veterinary service across the country.

One new small meat business has been recommended for registration in November and will commence operating soon.

Sampling activity during Quarter 2 was suspended due to labs not operating. However as of July 2020, all relevant labs have resumed normal operations and Quarters 3 and 4 sampling has been carried out i.e. veterinary medicine residue sampling, microbiological sampling of carcases and meat products and food additive sampling.

Face to face meetings and training have been replaced by conference calls, Zoom meetings and other online training. The whole-time veterinary inspector attended online training in September organised by FSAI entitled 'Principles of Intelligence Led Food Fraud Control' comprising 3 sessions of 3 hours each over a number of days as well as a Dog Control Webinar on 5<sup>th</sup> November (also attended by other Council staff involved in dog control).

#### **Library Development:**

- WCCC Covid-19 compliance and work from home systems are now established for staff and public safety.
   Smaller branches preparing for reopening with compliance work. Plans underway for building works to ensure long-term compliance, with a new ventilation system in Dungarvan Library along with an occupancy control system and new staff PCs installed in Carrickphieirish Library.
- Adaption of library services during closure to remain connected to the community including; Zoom library tours, online writing, scrabble and book clubs, window exhibitions, local radio, newspaper and social media campaign promoting online resources; highlighting themed Library eResources available for national campaigns such as International Men's day as well as sharing health and wellbeing information and supports along with partnering with local organisations for online events and activities.
- Focus on staff welfare and connectivity through new WCCC App WIRE, social zooms and Christmas charity
  raffle organisation. Staff training included; digital skills, setting up your own studio, video production,
  Rewarding Reads, panic and potential for digital preservation, sign language Tovertafel and sensory
  equipment, podcasting, Men's Health, gender equality, stress management, HSE health and wellbeing
  digital inclusion and minding your wellbeing.
