Economic Development

1. North Quays

 On 14th February 2020, the National Transport Authority announced funding of €12.6 million for the North Quays project. The comprises €400,000 for Strategic Development Zone (SDZ) Transportation measures, €6.2 m for the Sustainable Transport Bridge and €6m for Dock Road and Abbey Road Infrastructure works.

2. Tender processes

a. Enabling works

Tenders were received on 21st February for the proposed utility diversion works contract, these are currently being assessed by Roughan & O'Donovan, Consulting Engineers. The contract for demolition works is due to be issued shortly.

b. Main contract

An open industry event was held on 31st January for potential contractors. Roughan & O'Donovan presented the project and this was followed by a Q & A session. A Suitability Assessment Questionnaire (SAQ) for the main contact was issued on etenders on 21st February 2020.

3. SDZ Development

Falcon Real Estate Development Ireland submitting their application for the North Quays SDZ on 17th December 2019. Further information in relation to the application was requested by the Planning Authority on 18th February 2020.

4. Sustainable Transport Bridge, Transport Hub and SDZ Access Infrastructure

Detailed design for the Sustainable Transport Bridge, Transport Hub and SDZ Access Infrastructure are currently being finalised, these works will form part of the main contract.




Planning

Planning Applications Received - Countywide

63 Planning applications were received in the month of February countywide. This compares with 88 planning applications received in the same month in 2019.

Planning Decisions 2019 - Countywide

In the month of February 2020, 75 planning decisions were made. Of these, 67 applications were granted and 8 refused, representing a grant rate in the month of 89%. Permissions granted in the period by decision type are illustrated below:



Pre Planning Update- Countywide

To date in 2020, 88 pre planning applications have been received. These applications are currently being addressed.

Planning

National Marine Planning Framework (NMPF): Consultation Draft.

It is proposed to hold a workshop with the Plenary Council immediately prior to the March Plenary Council meeting. The workshop will inform the Council of the principles underpinning the NMPF and the key changes proposed in terms of how marine development is planned and managed and the new functions assigned to local authorities. The Consultation Draft of the NMPF is currently the subject of a public consultation process which runs until the 9th April 2020.

Development Plan

It is intended that the process to prepare the new unitary Waterford City and County Development Plan will commence the week beginning 23rd March. The initial phase of the plan preparation process will consist of an 8 week period during which written public submissions or observations can be made through an online consultation portal consult.waterford.ie, via email or in writing to the Senior Planner, Planning Department, Waterford City and County Council. All written submissions should relate solely to the proper planning and sustainable development of the area; however, requests or proposals for the zoning of particular land for any purpose cannot be considered at this Pre-Draft Stage and any such submissions will be returned.

It should be noted that submissions received by the Planning Authority will be published on the consultation portal on http://www.waterfordcouncil.ie within 10 working days of receipt, along with the name of the person making the submission in accordance with the Planning & Development (Amendment) Act 2018. Contact details however will not be published and people will be requested not to include personal, confidential or other sensitive information in submissions.

A number of public Information drop-in events are being organised across the city and county which will assist in informing the making of pre-draft submissions by the public. Full details of the location and times for these events will be provided through http://www.waterfordcouncil.ie and through local press.

At the Planning SPC meeting of the 25th February a number of issues relevant to the imminent development plan preparation were discussed, principally the servicing of towns and villages, renewable energy, core and settlement strategies and associated general land use zoning. It is intended that these topics, among others, will be discussed in more detail through workshops with the Plenary Council during Q2 & 3 of 2020 with a view to informing the content and policies of the unitary development plan.

Conservation Grants

The closing date for applications under the Built Heritage Investment Scheme (BHIS) 2020 and the Historic Structures Fund (HSF) 2020 was 5pm on the 27th January. The following is a summary of applications received:

Planning

BHIS – 34 applications for grant aid received by the closing date, the list of successful projects are awaiting approval by the Department of Culture, Heritage and the Gaeltacht and all applicants will be informed of decision on applications by early March

HSF: 3 applications for grant aid were received under the Historic Structures fund and were forwarded to the Department of Culture, Heritage and the Gaeltacht for consideration.

Conservation Works

Works are progressing to restore the signal box in Kilmacthomas, and the railway station, while the new stone work along the platforms is now complete. The tender for the repair of the Glasshouses in Mount Congreve has gone out to tender. It is hoped that works will be completed by the spring of 2021

Heritage

Woodstown Viking Site

A Draft Conservation Management Plan for the Woodstown Viking Site has been completed and will be issued for public consultation in March. The Plan incorporates a strategy for future research on the site, a public engagement and heritage animation strategy and practical management plan. Funding was provided by The Heritage Council for development of the Plan.



Decade of Commemorations

Around 130 people attended a conference to commemorate the contribution of Richard Mulcahy in Irish Military History on February 22nd in the Large Room of City Hall. Richard Mulcahy was born in 70 Manor Street. Speakers included John Bruton, David McCullagh, Pat McCarthy, Pat Taaffe, Kate Manning and Jim Ryan. The conference was organised by Archivist Joanne Rothwell and Heritage Officer, Bernadette Guest.



Planning

Dunhill Heritage Audit

Funding was allocated by the Creative Ireland Programme to carry out a Heritage Audit of Dunhill with the aim of informing a heritage tourism plan for the area to enhance pride of place, sense of place and attract visitors to stay in the area. The audit involved a community consultation meeting in November and final report was completed in December.



World Wetlands Day

World Wetlands Day was celebrated in the Anne Valley and Dungarvan on February 2nd last when around 50 people attended guided walks with Paddy Dwan and the West Waterford Eco-Group. The walk in Dungarvan focused on wintering birdlife in Dungarvan Harbour and over 15 species were observed. The Anne Valley walk looked at the constructed wetlands and how they benefit pollution control, wildlife and amenity.

In compliance with the Council's Vacant Homes Action Plan, Waterford City & County Council have an ongoing programme to deal with property vacancy that currently involves sixteen (16) Compulsory Purchase Orders that target twenty (20) individual properties. So far, fifteen (15) of these Compulsory Purchase Orders have been confirmed by An Bord Pleanala. These properties have all been identified as vacant, in private ownership and are located countywide. It is proposed to extend the initiative to reduce vacancy to all areas of the county.



originated from environmental enforcement staff are recorded as "internal CRM cases" and are shown in red on the graph. Environmental enforcement officers continue to investigate complaints received and monitor illegal waste issues, littering, dog fouling, fly-tipping, and illegal signage and issued litter fines where offences are detected. The Waterford City & County Councils Dog Wardens continue to investigate all dog control issue throughout the City & County.



Environmental Education & Awareness

Local Waste Prevention Grant

This grant supports communities to take steps on waste prevention, re-use and repair activities in their local areas, and encourage partnership between local businesses, schools, charities and voluntary groups. Waterford City and County Council is offering community groups an opportunity this year to promote waste prevention, creating an opportunity to look at waste differently and to determine if we can handle our resources better and encourage a circular economy. Previous examples of funded projects include up-cycling community workshops creating sustainable products from waste, food waste prevention, repair/up-cycling events for Re-Use Month (October annually), bicycle repair workshops and projects that encourage the elimination of single use plastic within a community setting. Local Anti Litter Awareness Grant

The Local Anti Litter Awareness Grant has been advertised in local newspapers and through social media channels. This grant is idea for groups who are interested in receiving funding for public education and awareness initiatives regarding litter or graffiti. National Tree Week

The Tree Council of Ireland, Coillte and Waterford City and County Council are again partnering for National Tree Week which takes place 21st -27th March. This year's theme is "Healthy Trees Healthy Planet" to promote tree health and the important role trees play in protecting our planet by taking on climate change and providing natural renewable resources. It also references the health benefits, both physical and mental, that trees and forests provide. Native tree saplings such as oak, birch, alder, and rowan will be available for collection through the offices of Waterford City and County Council in Waterford & Dungarvan. Schools and community groups are urged to first register their events with the Tree Council (www.treecouncil.ie) and then contact Waterford City & Council to obtain saplings (subject to availability).

Talks on recycling/waste prevention

Two talks about recycling/waste prevention were given in February, with another two planned for March and two for April. The groups to which talks are given range from active retirement groups and women's groups to scout groups, with group numbers varying between 10-70.

Tidy Towns

Tidy Towns groups are working towards entering this year's competition. Waterford City & County Council have been providing information and advice on projects completed in their area for inclusion in applications. Tramore was also been chosen to take part in Ireland's Best Kept Towns Competition.

Green Schools Programme

Environmental Services

As part of Waterford City and County Council's support of the An Taisce's Green Flag programme for schools, work is ongoing with schools to provide advice and support them in their work. Renewal visits for the next flag and first time assessments are also underway and will continue until the deadline of 27th March. These renewal visits cover topics such as energy, water, biodiversity, etc. while the first time assessment addresses litter and waste.

National Spring Clean

National Spring Clean is now in its 21st year and will take place in April this year. The campaign encourages every sector of society to actively participate and take responsibility for litter, by carrying out clean ups in their own local environment. Bags, litter pickers, gloves and high visibility vests are provided by Waterford City and County Council for any group, school or individual carrying out a cleanup during National Spring Clean, or any other time of the year. National Spring Clean has been coordinated by An Taisce since 1999 in partnership with the Department of Environment, Heritage & Local Government. The size and scale of National Spring Clean has grown steadily and significantly over the years.

Community Clean Ups.

Waterford City & County Council offer assistance throughout the year to the general public to clean up litter and illegally dumped waste from their local environs e.g. approach roads, local beauty spots, beaches and general public areas. Coastal communities are being engaged with and supported in conjunction with An Taisce's Clean Coasts programme. Waterford City & County Council support groups and individuals by providing the clean up materials and collecting the bags of litter for disposal.
