The Minister for Health, Stephen Donnelly T.D., has noted your correspondence regarding the Waterford City and County Council meeting of January 13th and the adoption of a resolution relating to children with Spina Bifida and Scoliosis and has asked me to respond to you.

Minister Donnelly acknowledges that waiting times for many hospital procedures and appointments are unacceptably long. It is of particular regret that children can experience long waiting times for orthopaedic treatment, especially for time sensitive procedures, and remains acutely aware of the impact that this has on children and their families. Minister Donnelly remains committed to working to reduce waiting times for patients.

Children with a range of needs rely on the orthopaedic service of Children's Health Ireland, for example children with Spina Bifida, hip deformity, and other orthopaedic needs. The complex patient needs of these children remains at the forefront of service provision.

The Department of Health has been working with the HSE and Children's Health Ireland to deliver improved paediatric orthopaedic services. In 2018 Children's Health Ireland was provided with an additional €9 million in funding to address paediatric orthopaedic waiting lists, including the provision of scoliosis services. This funding is recurring and has been provided in the base HSE allocation each year since 2018. The additional funding supported the recruitment of approximately 60 WTEs in 2018 and 2019 to enable the expansion of paediatric orthopaedic services. The posts relate to the multi-disciplinary team at diagnosis, pre-assessment, during surgery in theatre, and post operatively.

Children's Health Ireland continue to examine new and innovative ways to improve access to orthopaedic services. "Cappagh Kids" at the National Orthopaedic Hospital at Cappagh provides additional theatre

capacity for non-complex, age appropriate, orthopaedic procedures, freeing up much needed space at central CHI sites for children with complex, multi-disciplinary needs. Additional orthopaedic outpatient sessions are also now held at Cappagh, providing additional capacity to see and assess children on the outpatient waiting list.

Funding proposals submitted to the HSE by Children's Health Ireland for increased investment in paediatric orthopaedic services in 2022 and increased activity through 'Cappagh Kids' will be decided as part of the finalisation of the Waiting List Action Plan 2022. In addition the HSE has advised my Department that a proposal to fund an additional theatre at Temple Street is currently progressing through the normal HSE capital approval process.

Improving waiting times for hospital appointments and procedures remains a commitment of this Government. For 2022 an additional allocation of €250 million, comprised of €200 million to the HSE and €50 million to the National Treatment Purchase Fund (NTPF) has been provided in respect of work to reduce hospital and community waiting lists. The €250 million will be used to fund additional activity in both the public and private sectors. The €50 million additional funding provided to the NTPF brings its total allocation for 2022 to €150 million, and as a consequence there will be a budget of €350 million available to support vital initiatives to improve access to acute hospitals and community health services.

In addition, the Department, the HSE and the NTPF are also working on a Multi Annual Waiting List Plan to bring waiting lists in line with Sláintecare targets over the coming years. This process will be overseen by a Ministerial Taskforce, chaired by the Secretary General of the Department of Health and includes representatives from the HSE and National Treatment Purchase Fund.

Dear Minister Naughton,

On behalf of the South East First Citizens Forum (Mayors/ Cathaoirligh of the five County Councils of the South East Carlow, Kilkenny, Tipperary, Waterford City and County and Wexford), I am writing to express our strong view around the need to retain a full 24-hour search and rescue service operating from Waterford.

We see the need for a Rescue 117 helicopter based in Waterford as overwhelming. It provides an essential service to over 1 million people, across broad terrain from Wexford to as far west as Kerry. It has had increased activity over the past years, in particular given increases in domestic tourism. The service is having genuine local impact - in 2021, out of 145 missions there were 36 lives saved and 56 situations alleviated.

It covers one of Ireland's busiest international shipping routes, which will likely be further increased in the coming years to due the impact of Brexit. Offshore renewable energy development is also likely to grow rapidly in the area and the department's recent policy paper has specifically highlighted that Ireland's ORE 2030 targets will "primarily be met through the deployment of fixed pile turbines off the East and South East coast east and south east coast". This increased commercial activity will require ongoing safety support.

A cut in the South East service would both have a negative impact on the local response times for safety incidents in the South East and also put additional pressure on other bases. This is a paramount safety issues for our citizens and we would very much welcome your ongoing support on this as it moves to the procurement phase.

## N24/ N25 letter to Minister Ryan

Dear Minister Ryan,

On behalf of the South East First Citizens Forum (Mayors/ Cathaoirligh of the five County Councils of the South East Carlow, Kilkenny, Tipperary, Waterford City and County and Wexford). I am writing to express our collective concern, dismay and anger that no funding has been provided to progress either the N25 (Waterford to Glenmore) or the N24 project (Waterford to Cahir). These projects are both in the National Development Plan and the revised NDP as important priorities for Government to deliver. Both the N24 and N25 are integral to enhancing regional connectivity, increasing road safety and improving the quality of life of people in our regional towns. The funding cuts effectively put the two projects on hold.

This is concerning for a number of reasons:

- Continued safety risks: There have been 33 fatalities and 72 serious injuries on the N24
  Waterford to Cahir section alone over the past decade. The decision to put the project
  on hold means that the safety risk due to current road infrastructure continues.
- Uncertainty to people's lives: In the absence of clear final route selections, local development will be hindered. This will impact severely on local residents wishing to build family homes or develop their farm holdings which will be particularly disconcerting given the engagement efforts undertaken to date. Completing the preferred route selection is critical to avoid adding stress to landowners and providing property owners on the other route options certainty and allow them plan for their futures. Not to do this is grossly unfair.
- Economic development impacts: Delaying these road projects on significant lands over long corridors with no reasonable timeframe for conclusion of the process will have clear impacts on investment in the South East region. This creation of uncertainty for potential investors is particularly concerning given the South East's status as having the highest unemployment levels in the country. Both roads are also economically critical as they connect the South East region and our ports to the rest of the country.
- Environmental quality of life in regional towns: Heavy Commercial Vehicles (HCVs)
  represent up to 11% of daily traffic on the N24 and which pass daily through a number
  of regional towns and villages. This is having significant impacts in terms of air quality for
  local residents as well as impacting the viability of these towns as good places to live.
  Continuing to allow HCVs and large volumes of traffic to pass through town and villages
  which were never designed for will do little to deliver Government policies on Town
  Centre First and Placemaking.

- Sunk costs and value for money to exchequer: Approximately €5 million has already been spent in progressing these projects to this stage. If the projects remain on hold indefinitely, the investment on existing contracts and works to date becomes a waste of public funds as the projects will have to recommence at the first stage. Taking the projects through planning could facilitate the actual construction in Phases if that is what public purse requires.
- Strategic approach to N24: The proposal to progress the Cahir to Limerick
  Junction section of the N24 in isolation of the Cahir to Waterford project is difficult to
  rationalise. The N24 is the Waterford to Limerick Road, it is the economic corridor
  between the two cities and both sections need to be upgraded to meet modern needs
  and standards.

Whilst the funding may not be currently available to commit to actual construction of the projects, we would request that the Consultants be approved to complete the Stages they were procured to undertake and take both projects through planning. It will take a number of years to prepare and obtain planning consent and stalling/delaying at this time will have serious implications for the actual delivery of the project in our lifetime.

## Specifically, we request that:

- €1.5m is allocated in 2022 for the N24 (Waterford to Cahir) to ensure that phase 2 works progress.
- 2. €2m allocation over 2022 and 2023 for the N25 (Waterford to Glenmore) to ensure that the development completes phase 4.




# **Developmental Trauma leads to Anxiety and Depression**

# Healing the Wounds of Trauma


- Chemical support for the patient to help him tolerate the intolerable feelings inside.

# **Adult to Adult Communication**


When we speak to someone from the Adult ego state.....the other person will ALWAYS reply in Adult. We will sound interesting and respectful.



If we speak to someone in Parent the other person will ALWAYS reply from his Child ego state. The Person speaking from Parent will sound more critical, authorative and powerful but the other person will feel like a Child, critisised, powerless, hopeless, voiceless. Long term this leads to depression in the individual functioning from Child. Those individuals functioning from Parent are not good company.



Ulterior transaction= sarcastic, patronising, or ridiculing. This is pretending to speak from Adult but the real meaning comes from Parent or Child




# The Drama Triangle

# **Attachment**

Every child forms an attachment pattern with its primary caregiver within the first three years of life. The style of attachment will affect all his future relationships from thereon.

John Bowlby, the father of attachment, stated that:

"In the working model of the world that anyone builds, a key feature is his notion of who his attachment figures are, where they may be found, and how they may be expected to respond." (Bowlby, 1973)

# Secure Attachment

The child's need were met at the appropriate times in his life. He usually grows up to be calm, confident and compassionate, and usually reaches his full intellectual potential. He experiences the world as a safe place and he is comfortable and friendly in society.

# **Ambivalent Attachment**

The primary caregiver was anxious, ill or intermittently absent, something major happened in the household, or had an ambivalent attachment style themselves. The child experiences the caregiver as loving but **unpredictable**. Hence the person develops antenna from very early on, to assess the caregiver. These children become very good a reading people. As adults they have a good sense of other's moods etc, but they become **preoccupied** with people and loved ones and often suffer from anxiety or low-grade depression. They generally connect well with people and often work within the caring professions.

# **Avoidant Attachment**

The caregivers in this style were themselves avoidant and dismissive. The child was ignored and learned to be self sufficient from an early age. Might have been left cry himself to sleep. As adults this style of attachment can appear very controlled or secure but deep down they feel anxious and lonely. They find relationships a challenge and often find it hard to read people. In that way they are the opposite to the ambivalent. They become dismissive adults, often not recognising when they are tired or ill.



# Disorganised Attachment– Unresolved Adult

People with this style of attachment had a neglected or abusive childhood and rarely felt safe. They were afraid of their caregiver so in times of stress they felt alone and uncared for. They often end up in state care. As teens and adults, they generally have serious addiction problems, become promiscuous and have antisocial behaviour. Because they never felt safe, they have a very poor sense of danger. It's as if they cannot judge safety from danger and so often end up in the criminal justice system.
