



### **EOLAS TÁBHACHTACH**

- Caithfidh ainm agus seoladh an té atá ag eagrú nó ag déanamh bholscaireachta ar an ócáid a bheith in airde ar an gcomhartha.
- Ní bheidh aon chomhartha/phostaeir níos mó ná 1.2m<sup>2</sup> (4 through x 3 through) i méid.
- Moltar dóibh siúd atá ag crochadh phostaeirí a bheith go mór san airdeall ar bhóithre, nó in aice le bóithre, agus bheith ar an eolas maidir lena sábháilteacht fhisiciúil féin agus sábháilteacht daoine eile a úsáideann na bóithre, m. sh. ag trasnú bhóithre gnóthacha, a bheith sa bhealach ar dhaoine ar an gcosán, ag páirceáil fheithiclí srl.

### **Is ceart na treoiríníte seo a leanas a leanúint chun a chinntiú nach mbeidh na Comharthaí/Postaeirí ina gcontúirt don bpobal:**

- Is ceart comharthaí/postaeirí a chrochadh ag íosleibhéal 2.5 méadar os cionn chosáin, raoin rothar nó aon áit go bhfuil teacht ag coisithe air.
- Ní cheart comharthaí/postaeirí a chrochadh ar chuailí lampaí ar a bhfuil soláthar líne leictreachais lastuas díobh, ar chuailí soilse tráchta, ar uchtbhallaí droichid, ar uasbhealaigh, ar dhroichid do choisithe, nó ar bhacainní tráchta ar thaobh an bhóthair.
- Ní cheart comharthaí/postaeirí a chrochadh ar nó in aice le timpealláin, achomhail nó soilse tráchta, mar go gcuireann siad isteach ar infheictheacht tiománaithe, rothaithe srl; is ceart iad a chuir 50 méadar siar ó aon cheann des na

láithreacha seo, ar stráicí díreacha na mbóithre

- Ní féidir le comharthaí cur isteach ar chomharthaí bóthair reachtúla nó soilse tráchta/coisithe in aon tslí
- Caithfidh comharthaí/postaeirí a bheith daingnithe go maith leis na cuailí le ceangláin ('*cable ties*' nó a leithéid) ionas gur féidir iad a bhaint anuas gan dochar dos na cuailí.
- Caithfí gach comhartha/postaeir a bhaint anuas laistigh de 7 lá ó dheireadh na hócáide. Caithfí na ceangail a úsáidtear chun na Comharthaí/Postaeirí a chrochadh a bhaint ón láthair chomh maith nuair atá na Comharthaí/Postaeirí á mbaint anuas laistigh de 7 lá ó dheireadh na hócáide.
- Ní ceadmhach Comharthaí/Postaeirí a bheith cosúil le comharthaí bóthair reachtúla.



### **IMPORTANT INFORMATION**

- Signs must carry the name and address of the person who is promoting or arranging the event.
- No sign/poster shall be more than 1.2 square metres (4ft. X 3ft) in area.
- Please be advised that those erecting posters should exercise extreme caution when on or near roadways and should be aware of their own and other road users physical safety, e.g. crossing busy roads, obstructing footpaths, parking of vehicles etc.

### **The following guidelines should be followed to ensure that posters do not present a hazard to the public:**

- Signs / Posters should be erected at a minimum height of 2.5 metres above footpaths, cycle tracks or any area to which pedestrians have access
- Signs / Posters should not be erected on lamp standards with overhead line electricity feed, traffic signal poles, bridge parapets, overpasses, pedestrian bridges, or roadside traffic barriers
- Signs / Posters should not be placed on or at roundabouts, junctions or traffic lights, as they are a hazard to the visibility of the motorists and cyclists etc; they should be placed 50 metres back from any of these locations, on the straight sections of the roads
- Signs / Posters should not obscure statutory road signs or

traffic/pedestrian signals in any way

- Signs / Posters should be securely fixed to poles with cable ties or similar material to facilitate removal without damage to the poles
- All Signs / Posters are to be removed within the period of 7 days after the event finishes. Ties used in securing the Signs / Posters to the poles / posts are also to be removed when the Signs / Posters are being removed, within 7 days of the event
- Signs / Posters shall not resemble statutory road signs
