

The Local Enterprise Office has met and worked with producers and crafters and at Christmas put together a pop-up shop option for them to share and showcase their wares at Winterval.

Major Projects – Progress Report up to January 2nd 2018

- 1. Greenway:-
 - All planned civil works have now been completed. Some small snagging works and planting continue in some places.
- 2. City Centre Rejuvenation Works:-
 - Works for the new street lighting in John Street, Applemarket and Lady Lane on-going. Existing lighting poles in John Street are being removed and paving at those locations patched following installation and testing of new building mounted lights.
 - Work in Arundel Square is progressing. Works to south end of the Square are progressing with a view to completing works by early February in this area
 - The works on Michael Street North, originally scheduled to begin in 2018, have been completed.

Contractors Programme

- Work on the detailed design of the City Centre Access part of the Rejuvenation project is ongoing. An interim scheme in the Manor Street/Poleberry/Bath Street to allow for the implementation of the new one way system will be implemented in January. Some small finishing works in Railway Square, Manor Street, Cork Road, Bath Street and College Street will then continue for a number of days. This scheme will facilitate the building of the Hennessey's Road/Browns Lane/Castle Street Scheme which is out to tender at the moment and will commence construction early in 2018.
- 3. North Quays:-
 - The public display phase of the SDZ Draft Planning Scheme finished on November 30th and a report is being prepared for the Members.
 - The CPO for the lands associated with the North Quays development had an Oral Hearing on October 24th with An Bord Pleanala and the outcome is awaited.
 - A proposal under Part VIII of the Planning and Development Act in respect of the Hennebique Building is on Public Consultation at the moment. A report will be brought to the Members when this has been completed.

4. Mercyhurst:-

There is no substantive progress to be reported at this time.

5. Planning and Land Use Strategy - Review of Bridge Options:-

A review into the provision of additional bridges across the R. Suir in the city to carry vehicles has been finalised. The report will be brought to the members for consideration in due course.

6. Work has commenced to prepare plans for the construction of the recently funded access roads in Gracedieu and Kilbarry under the LIHAF scheme. The Chief Executives Report on the Part VIII planning process was adopted by the Metropolitan Members in December. It is anticipated that the two access roads will progress to construction stage by the end February 2018.


Development Management

Planning Applications Received – Countywide

Christmas week is traditionally the busiest week for the planning department as applicants tend to lodge applications prior to Christmas so as to achieve a start in the spring. Planning applications received during the Christmas period are still being processed and a definitive annual figure will be available in early January. It is envisaged that planning applications in 2017 will be in the region of the low 900's, representing approximately a 6% year on year increase in planning applications.

74 planning applications were received in the month of December (to 27th) 2017. This compares with 83 planning applications received in the same period in 2016. To the 27th of December a total of 903 planning applications have been received. This compares with 849 applications received in the same period in 2016.

Planning Decisions 2017 - Countywide



In the full calendar year of 2017, 743 planning decisions were made. This compares with 723 decisions which were made in 2016. In 2017, 693 applications were granted and 50 refused, representing a grant rate of 93.2%.

Pre Planning Update- Countywide

A total of 508 preplanning applications have been received this year up to the 19th December 2017. This compares with 523 pre planning applications which were received for the full year of 2016. A new mechanism was introduced whereby meetings were established with the Area Planners on a weekly basis.

Forward Planning

Development Plan Variations

Variations No.3a: **Vacant Site Levy and 3b Part V Social Housing Provision**. Both variations of the Development Plans were adopted in the first quarter of 2017.

Vacant Sites Register

There is a statutory obligation on the Planning Authority, pursuant to The Urban Regeneration and Housing Act 2015, to establish and maintain a Vacant Sites Register. Work was undertaken on the assessment of vacant sites throughout the county for inclusion in the Register. During May a workshop was held with the Elected Members. A total of 21 sites were identified and subsequently placed on the register.

Draft National Planning Framework (NPF)

The National Planning Framework - "Ireland 2040 – Our Plan" was published in Draft format in September. The document sets out how Ireland will respond to key planning challenges in the period to 2040 with particular emphasis on providing capacity for population increase, job creation, housing, environmental challenges in terms of climate change and the movement to a low carbon economy. The document is available online at http://npf.ie/draft-of-ireland-2040/. The Forward Planning Section was engaged in making an individual submission on the draft NPF and in conjunction with Kilkenny, Carlow, Tipperary and Wexford County Councils have made a combined submission. Both submissions sought to strengthen the role and function of the South East Waterford City Region.

Review of the Record of Protected Structures (RPS) and Variation no. 4 of the Development Plan(s) relating to Architectural Conservation Areas.

Work was completed in 2017 on the review of the RPS for the Metropolitan District. The official review process commenced in October 2017 with a review being undertaken of RPS as it relates to Waterford City and the associated Waterford City Development Plan. The relevant owners/occupiers of structures proposed for addition or deletion were notified individually in addition to the owners/occupiers of structures already on the RPS where details are to be amended. Both processes have run concurrently and have entailed periods of public display and invitation of submissions/observations. Both processes should be completed by early 2018.

In conjunction with the above, ongoing technical support is provided by the Department both in house and also to the public.

Conservation and Heritage

Conservation

The upturn in the property market has had a positive impact for historic buildings in the County. Some larger properties in urban and rural areas which were empty for past number of years were purchased and are in the process of renovation. Grant aid available from the Heritage Council, Department of Housing and the Built Heritage Jobs Leverage Scheme and the Georgian society benefited residential/ commercial and community projects. Other projects included the repair of several thatch roofs around the county, and repairs of windows and roofs of private dwellings. These works benefit the owners and their buildings but also contribute to upgrading the streetscape.

The annual Built Heritage Investment Scheme (BHIS) and Structures at Risk Fund (SRF) administered by the Council both drew to a close at the end of November. Funds in excess of €260,000 were allocated for the schemes. Both schemes funded residential, commercial and community projects assisting in the carrying out of structural repairs and repairs to windows, roofs, doors etc. The three key projects funded under the SRF in 2017 were the Bishops Palace, Waterford City, St. Carthage's Cathedral, Lismore and Cappoquin House while the BHIS funded 26 projects across the county.

The Built Heritage Investment Scheme (BHIS) and the Structures at Risk Fund (SRF) will once again be in operation in 2018. The councillors and public will be informed with the funding is announced by the Department. If the councillors have any projects in mind they can contact either Cecily Johnston or Rose Ryall and information can be sent to interested parties.

Heritage - Review of Main Projects for 2017:

Waterford Heritage Plan: Waterford's Heritage Plan 2017-2022 was adopted by Council during Quarter 1.

Heritage Week ran from August 20th to 27th 2017, a wide variety of events took place accross the County which were well supported.

Heritage Funding: The Heritage Council funded projects under the 2017 Heritage Plan including Ecological Survey of St. John's River, Habitat Management Plan for Kilmacleague Wetland, Support for Community Archaeology projects at Round Hill, Lismore and Gallows Hill Dungarvan, Decade of Commemoration events for 2017 & 2018 and Heritage Week programming.

Launch of Waterford Greenway: March 2017 saw the launch of Waterford Greenway. A heritage event was held which included a photographic exhibition on railway heritage displayed in Kilmacthomas library, wildlife walks with Paddy Dwan, guided walk to Woodstown Viking Site with Archaeologist James Eogan and "Stop, Look and Listen Trad songs of the Greenway" with Michael Fortune.

Strategic Policy Committee 2017

The SPC held 4 meetings during the year. The following topics and policy issues were discussed at the meetings:

- Changes to Part V Social Housing Provision with associated variations to the Development Plans.
- Vacant Site Levy and associated Register with related variations to the Development Plans.
- Waterford City and County Council Heritage Plan 2017 -2022.
- Review of the Record of Protected Structure and the adoption or Areas of Architectural Conservation Areas (ACA) with related Development Plan variation.
- Local Infrastructure and Housing Activation Fund (LIHAF).
- National Planning Framework: Details of the draft NPF as they relate to Waterford City and County Council were highlighted, which formed the basis of subsequent debate on a range of issues and an input into Waterford's submission.
- Development Plan Review: As a precursor to the development plan process, the future Policy approaches regarding Tourism Accommodation and Rural Housing were discussed.

Planning and Information Technology

Website Development

New content continued to be developed for the Planning website in 2017. This investment allied to the general upturn in construction activity has resulted in the achievement of significant additional visits to the Planning website. Visits to planning web pages on www.waterfordcouncil.ie in 2017 amounted to 183,175 visits which represents average visits in excess of 3,500 visits per week.

Last year in the same period there were 160,696 visits, therefore there was a healthy increase in visits of 14%. The equivalent visits in 2015 amounted to 142,099. Indicators across other measures such as unique page views, the time taken on each page, bounce rates all showed positive trends over 2016. Development of new relevant content will continue into 2018.

MapAlerter and Twitter

Planning information is now available on the Map Alerter and Twitter platforms.

The **MapAlerter App** for Android and iOS is a great way to receive planning alerts which are local to your area. "App Alerts" beep in like a normal text message, but they can include a lot more information. To use the service, the MapAlerter App needs to be downloaded on to your phone from the App Store or Google Play.

On the **Twitter** platform, all of the statutory planning lists are tweeted on a weekly basis. To access the feature, access and follow the Waterford City and County Council account @WaterfordCouncil.

E-planning

The Planning Section is managing a project currently underway to deliver an e-planning solution which integrates with the introduction of electronic systems currently being developed in An Bord Pleanála. It is Government Policy to provide an e-planning solution and this is referenced in recent policy documents such as Rebuilding Ireland and the Broadband Strategy.

The e-planning system will provide a better service to the public (for example earlier visibility of planning applications, online planning submissions), will allow agents to 'build' their application before submission, will reduce the printing, copying and scanning of documentation and will facilitate electronic interaction between Local Authorities and An Bord Pleanála and Prescribed Bodies. The system is due to go live in 2018. Communications will issue to all of the key stakeholders as the project progresses.

Bóithre agus Iompar Roads and Transportation

Storm Ophelia - Funding

A funding application to address the immediate clean up and associated costs following Storm Ophelia was made to the Department of Housing, Planning and Local Government for €507,450 which was granted in full. To date the Council has had no decision or notification in relation to an application for funding of €1.320m to repair structural damage to our coastal defences, road pavement damage, culvert and bridge damages.

Local Improvement Scheme 2017

Total funding of $\in 660,825$ was provided by the Department for the completion of LIS projects in 2017. Although the timescale was very tight for the delivery of the works all projects were completed by year end.

Road Works Programme 2018

Meetings to agree the Road Works Programme for the coming year will be arranged this month for each District.

Winter Maintenance Programme

Gritting and salting of roads continued during December with crews remaining on call during the Christmas holiday period.

Fire Service Operational Activity:

Total call outs to incidents attended by the 10 fire stations of the Fire Authority are shown for the year to date and for the month of December. Special services include road traffic accidents, road hazards, chemical incidents, flooding and non fire rescues. Good intent false alarms include alarm system malfunctions, alarm systems alerting due to factors other than fire (e.g. steam, dust, power surges, break glass units accidently set off etc), persons mistakenly observing fires and calls to controlled burning. Malicious false alarms occur where persons deliberately alert the brigade where no emergency exists. For comparison purposes 2016 figures are also included.

Planning for the 2018 programme is almost complete. The Comhairle Cooordinator and Community Dept. liaison have met regarding the 2017 Annual report and 2018 Funding Request which is to be submitted to the Department - they are almost fully complete and ready for submission.

Pride of Place:

The entry for the 2018 National Pride of Place awards will be Tramore and Waterford Arch Club. Work with this group will commence early in 2018 with a view to matching the success of the Portlaw Task Force in the 2017 awards.

<u>JPC</u>:

Final draft of JPC Strategic Plan 2018-2023 was ratified at JPC meeting held on 4th December.

Waterford Age Friendly Programme:

The feedback from the launch of the WAFA Strategy document was hugely positive from all attendees. The work of the action groups is underway with significant progress on delivery of thematic area actions expected early in 2018.

Communities Facilities Scheme 2017:

All successful groups have received their grant.

RAPID:

New RAPID grant scheme for disadvantaged urban areas. Successful applicants notified of grants.

Healthy Waterford

Healthy Waterford is now the Health and Wellbeing sub-committee of Waterford LCDC. Healthy Ireland funded projects commenced in December.

Arts Report

Arts Festivals, venues and arts practice grants were passed at the December Plenary meeting. Successful applicants were advised of their standing.

Contracts have been signed for the former SEA Rooms in O'Connell Street. The building will undergo a cosmetic renovation with an opening date as the new home for the Waterford Collection in July 2018. Greyfriars Gallery will close at the end of March 2018 for renovations to become a Museum of Time.

The Old Market House Arts Centre, Dungarvan is held it's annual Christmas Art and Crafts exhibition that ran until December 22nd. The next exhibition: Landscapes and Portraits, is a selection from the Waterford Collection.

Arts in Education projects in schools around the City and county are ongoing.

Waterford Artlinks bursaries 2018 for artists in all disciplines continue to be promoted with an end of January closing date.



Environmental Complaints

The Waterford City & County Councils Dog Warden continues to investigate all control of dogs issue throughout the City & County.

Environmental Education & Awareness

Community Clean-Ups

Waterford City & County Council continues to offer assistance throughout the year to the general public every spring/summer season to clean up litter and illegally dumped waste from their local environs e.g. approach roads, local beauty spots, beaches and general public areas.

Green Flag Programme

As part of Waterford City and County Council's support of the An Taisce's Green Flag programme for schools, work is ongoing with schools to provide advice and support them in their work. Renewal assessments for the next flag have already begun and will continue until the end of March. A total of 51 schools are due to renew their Green Flag this school year.

Two Green Schools Roadshows are scheduled to take place in the coming months. These Roadshows will help refresh, revise and revitalise the Green-Schools programme for those schools who are working on the Global Citizenship theme. Green School committee members will be led in a series of activities and engaged in some informative presentations. Schools will explore ideas for their own Green-Schools action plan, and get tips and hints for the school year. **Local Litter Awareness Grant**

In order to facilitate community and school clean ups during National Spring Clean and over the Summer, this grant will be advertised in early February, with a deadline of early March for applications. This will enable notification to be issued to successful applicants and payment of the first half of the grant to be paid out by April; projects can begin from the second quarter of 2017.

Local Authority Prevention Network (LAPN)

A joint application was submitted by Waterford City & County Council and Wexford County Council was submitted for the funding of a food waste prevention initiative under a Local Authority Prevention Network (LAPN). This food waste prevention project was approved for funding for €11,285. Work has begun on this initiative and will continue until the end of 2017. As part of this project, Stop Food Waste workshops were allocated to groups to educate participants about food waste prevention. These workshops help participants to cut down on their food waste (and costs; it can save a household up to €60 a month). The short animated video produced for this project will appear in cinemas late December – mid January. This will also be used on social media, on YouTube, in schools, etc in both Irish and English. It is hoped to use images from this video for use as colouring competitions for schools, use at food waste prevention events, etc.

Local Waste Prevention Grant

A waste prevention budget is set out in the Southern Region Waste Management Plan and amounts to €16,194.15 for Waterford City & County Council (it was agreed regionally to allocate a minimum spend of €0.15/inhabitant on local prevention projects). In 2018 30% of this waste prevention budget has been allocated as a small grant to communities for waste prevention projects. This grant will be advertised in late January with a closing date for application of early March.

Food Waste Prevention Grant

A joint application was submitted by Waterford City & County Council and Wexford County Council for the funding of a food waste prevention initiative under a Local Authority Prevention Network (LAPN). This food waste prevention project was approved for funding for €11,285. As part of this project, Stop Food Waste workshops have been organised to educate participants about food waste prevention. The short animated video produced for this project will be launched and appear in cinemas in mid January. This will also be used on social media, on YouTube, in schools, etc in both Irish and English to raise awareness about food waste prevention. Images from this video will be used in competitions for both primary and secondary schools, use at food waste prevention events, etc.
