1. City Centre Rejuvenation Works:-

- The contract is close to substantial completion in all areas with lighting and snagging being finalised.
- The entire works, with the exception of snagging, are scheduled to be substantially complete by end of April 2018, ahead of the previously programmed June completion date. It is envisaged that Murphy International Ltd will continue to have a presence on site snagging and completing public lighting works until mid June.

- The Manor Street/ Poleberry/ Bath Street traffic scheme is operating and working satisfactorily. Permanent signage, line markings and street furniture is currently being installed.
- Preparatory design works for the Parnell Street section of the WIT to City Centre Greenroute project have commenced.
- The construction contract for the Hennessey's Road/Browns Lane/Castle Street
 Scheme is due to be awarded shortly & it is anticipated to commence works May 2018.

2. North Quays:-

- The Waterford North Quays Planning Scheme was appealed to An Bord Pleanála and an oral hearing is expected. Following the oral hearing, a decision on the Scheme is expected by 10th July 2018.
- The decision is still awaited from An Bord Pleanála Oral Hearing relating to the CPO for the lands associated with the North Quays infrastructure development, anticipated decision date is 3rd July 2018.
- Preliminary Design Documents for the North Quays were issued 18th April 2018, they
 are currently being reviewed and to be incorporated within the tender
 documentation for the final design consultant which is due to be issued shortly.
- Additional site survey, investigative and design works are currently ongoing.


Planning Applications Received – Countywide

75 Planning applications have been received in the month of April 2018 to the 27th April. This compares with 75 planning applications received in the same period in 2017.

From the 1st of January 2018 to the 27th of April, a total of 289 applications were received. In the same period in 2017, exactly the same number of applications (289) were lodged.

Planning Decisions 2018 - Countywide

In the month of April, 63 planning decisions were made. Of these, 61 applications were granted and 2 refused, representing a grant rate of 96.8%. Planning decisions made in the period by decision type are illustrated in below:



Pre Planning Update- Countywide

A total of 182 preplanning applications have been received this year up to the 28th April. These preplanning applications are currently being processed.

Forward Planning

Proposed Variation no. 4 of the Waterford County Development Plan 2011-1017, Waterford City Development Plan 2013-2019 and Dungarvan Town Development Plan 2012-2018

It had been intended to progress to public consultation on this proposed variation immediately following the workshop at the March Plenary Council meeting; however given the debate at the workshop and the conflicting views expressed, this process had been put on hold to facilitate further discussions with the Plenary Council.

Having regard to the concerns raised at the Plenary Council and the role of the SPC in formulating the proposed policy variation it is now intended to hold a second workshop with the Plenary Council immediately prior to the May Plenary Council Meeting.

On the basis of an agreed conclusion at workshop the public consultation on the variation can commence.

The public consultation process will provide for the following:

- Publication of notice of the proposed variation in a local newspaper.
- Minimum 4 week public display period during which written submissions will be invited.
- Submission of a Chief Executive (C.E.) Report to the Elected Members on submissions received for their Consideration not later than 8 weeks after publication of the newspaper notice.
- Resolution of the Council to make the proposed variation or not to make it as the case may be. The Resolution shall be made not later than 6 weeks following receipt by the Elected Members of the C.E. Report.

Built Heritage

A provisional offer of €104,000 grant funding under the Built Heritage Investment Scheme (BHIS) has been made by the Department of Culture, Heritage and the Gaeltacht (DCHG). The Council has received 30 applications for the grant funds and of these, 17 applications qualified for funding under the scheme. Details of the qualified applications have been forwarded to the DCHG and a response is awaited in the coming weeks.

In addition to the BHIS, 5 applications have been received for draw down of funding from the DCHG under the Structures at Risk Fund (SRF) and these have been forwarded to the DCHG for consideration. Details of the qualified applications have been forwarded to the DCHG and a response is awaited in the coming weeks.

Taking in Charge of Estates

The Council is reviewing the resources assigned to the Taking in Charge Section with a view to supplement the existing staff compliment which will allow progress to be made on priority areas. In addition, the Taking in Charge report is being reviewed with further relevant detail to be provided. The new format report will be updated to the Districts on a quarterly basis commencing in June.

Roads and Transportation

Road Works Programme 2018

The Roadworks Programme commenced on 11th April and is progressing well in the Dungarvan/Lismore area. Following the completion of works in the Dungarvan/Lismore District works will move to the Comeragh area towards the end of May.

Storm Emma Recoupment

As requested by the Department of Planning, Housing and Local Government an application for recoupment of expenditure incurred for the immediate clean-up costs from Storm Emma of €532,009 was submitted. In addition to these costs the storm caused significant longer term damage to the road network estimated at €1,155,000 and this has also been notified to the Department, should additional funding become available. Notification of the funding allocation was not known at the time of preparing this report.

Community Involvement Scheme 2018

A submission of 20 projects has been made to the Department of Transport, Tourism and Sport in respect of the Community Involvement Scheme for 2018. The Community Involvement Scheme provides funding for works on private roads where the local residents engage with the Council and provide either a financial contribution or work to assist in the upgrade of the road. Funding allocations will be announced by the Department this month.

Local Improvement Scheme 2018

Approval has been received for the 12 Schemes submitted to the Department of Rural and Community Development for grant aid of €282,000. Applicants have been notified and work will commence as soon as possible to ensure all Schemes are completed by the July deadline.

Community Services

Social Inclusion:

- New SICAP programme 2018-2022 launched by Minister Ring on 20th April. SICAP, which is cofunded by the European Social Fund, supports disadvantaged communities and individuals including unemployed people, people living in deprived areas, people with disabilities, single parent families, people on low income, members of the Traveller and Roma community and other disadvantaged groups. €1,120,415 has been allocated to Waterford under the programme.
- Exploratory meetings are being carried out in advance of the drawing up of a Migrant Integration Strategy.
- Meeting of the Waterford Traveller Interagency Group held on 28th March. Consideration being
 given to implementing the Yellow Flag Programme. The Yellow Flag Programme is a progressive
 equality & diversity initiative for primary and secondary schools which promotes and supports
 an environment for interculturalism. Traveller Genealogy Exhibition opened on 19th April in the
 Civic Offices, Dungarvan.

Waterford Rural Development programme:

- Following the workshops held in Tramore, Lismore, Ballymacarbry, and Kilmacthomas, 17 no.
 Expressions of interest were received for funding under the Rural Tourism and Enterprise
 Development Themes. The estimated spend is approximately €1m.
- 13 no. projects were considered by the Independent Evaluation Committee during April with an estimated spend of €550,000. A further 11 no. projects progressed through compliance stage during April and 9 no. projects will placed before the LCDC for decision at meeting to be held on May 10th.
- During April 3 no. projects with a total value of €54,491.25 received final approval from the Department of Rural and Community Development.

Comhairle na nÓg:

Support at events is underway for the Spring/Summer season. Action meetings have been taking place by the various sub-committees that have been established by the young people and are being facilitated by the coordinator in order to progress this years' topic of Homelessness. Team building events have been taking place in Woodstown.

Pride of Place:

An initial meeting with Waterford Pride of Place entrants (Tramore and Waterford Arch Club) for IPB All island Pride of Place Awards 2018 took place on April 26th. The competition process and the plan for the remainder of the year were discussed as well as the group's current activities. Further planning meetings are to be scheduled in the coming weeks.

Waterford Age Friendly Programme:

The work of the action groups is progressing. The Older Persons Council has been established and a representative attended the National Age Friendly Awards in Monaghan on April 11th. Within the next month, the Waterford Age Friendly Alliance will meet and it is planned that the new alliance structure will be adopted. Reports from all thematic subgroups will also be presented at this meeting detailing progress to date. Engagement with the national Age Friendly Programme continues.

The Arts Office is currently accepting applications for the following bursaries all with May deadlines: The Tyrone Guthrie Arts Bursary, the Drama League of Ireland Summer School, the Irish Youth Choir Summer School, The Irish Youth Orchestra Summer School, Blas Traditional Music Bursary at the University of Limerick. Also advertised is the Ted and Mary O' Regan Arts Bursary.

This year Poetry Day Ireland was expanded and celebrated in Waterford, Tramore, Dungarvan, Cappoquin, and Kill. There was a free Poetry podcast from WIT. The Molly Keane Writers Retreat Ardmore held a reading with Mark Roper and Lani O' Hanlon and were delighted to have Ireland's foremost singer songwriter Christy Moore as a guest.

The Treelines & Skylines exhibition continues in Greyfriars Municipal Art Gallery until May 18th.

Directors of the prestigious Museum of Contemporary Art (MOCA Jacksonville) are visiting Waterford on May 22nd – Greyfriars, GOMA, Garter Lane and possibly the new Gallery space in 31&32 will be visited. The Arts Office is hoping to arrange an exhibition 'swap' with MOCA for 2019.

The Perspectives from the Margins exhibition by Anthony Mackey has just finished a successful run in GOMA Waterford. A number of Councillors visited the exhibition on the closing day and

Rogue Gallery and Studios are hosting the LúaC Collective exhibition from May 4th.

Studio 20ten Gallery & Workspace are hosting a special 'Bealtaine' exhibition featuring a selection of new work by members of River Barn Artists - the Cappoquin based art group. The exhibition runs from May 1st to June 2nd.

Arts in Education projects in primary schools around the City and County are ongoing. In particular ten schools are currently involved in a project to animate the stages for the Summer in the City programme.

The Arts Office is hosting Carnation Theatre Company in two Health Care settings in West Waterford to celebrate the Bealtaine Festival – Celebrating Creativity as we age.

The Old Market House Arts Centre, Dungarvan, current exhibitions are by Ciara Gormley, Dungarvan, Anna Maria Leavy, Co. Westmeath, Margaret Walsh, Cork and students of the VTOS, Dungarvan Arts & Crafts course. The Arts Centre hosted a successful exhibitions launch for these artists during the West Waterford Festival of Food, plus the venue also hosted children events.

Ravenna has been working on its plan since 2011 and have experience in community development.

Prosecution of Unauthorised Waste Collector

On 27th March 2018, Waterford City and County Council brought a prosecution In Clonmel District Court against an unauthorised waste collector. This collector was collecting waste in the Clonmel area, prior to bringing the waste to his site in Co Waterford and burning the waste there.

The prosecution was for offences under section 32 of the Waste Management Act 1996 as amended, (WMA) for causing environmental pollution, section 34 of the WMA for collecting waste without a waste collection permit, and section 4 of the Waste Management (Prohibition of Waste Disposal By Burning) Regulations 2009.

The defendant agreed to plead guilty, and two further offences were withdrawn by the council.


The council solicitor gave a summary of the facts to the court and emphasised to the Judge that this had been a commercial enterprise and that the defendant had advertised the waste disposal service via social media.

Having heard the evidence in the case Judge Finn imposed a fine of €1,000 for each of the three offences, totalling €3,000 and awarded costs to the council of a further €3,627.63.

Waterford City and County Council decided not to prosecute the persons who used the unauthorised waste collector, as they co-operated and provided statements to the council to assist in the prosecution of the unauthorised collector.

Environmental Complaints

The following graph shows the top 10 category of complaints received. Environmental Inspectors continue to investigate complaints received and monitor illegal waste issues, littering, fly-tipping and illegal signage and issued litter fines where offences are detected. The Waterford City & County Councils Dog Warden continues to investigate all control of dogs issue throughout the City & County.

Free Household Hazardous Waste Drop Off Day

This free collection is for domestic households only and will be advertised on local papers, radio and social media.

National Spring Clean

National Spring Clean took place throughout the month of April. Community groups, youth groups, schools, Tidy Towns groups, etc. took part by holding a cleanup of their local area. Waterford City & County Council offer assistance throughout the year to the general public every spring/summer season to clean up litter and illegally dumped waste from their local environs e.g. approach roads, local beauty spots, beaches and general public areas. Through the An Taisce's Clean Coasts Programme the Council has engaged with and supported a number of coastal communities. Waterford City and County Council provides cleanup materials for beach clean-ups which help to remove considerable quantities of marine litter from our coastline. On Earth Day approximately 180 volunteers from Sanofi took part in beach cleans on 18 beaches along the Waterford coastline. Waterford City & County Council supported them by providing the clean up materials and collecting the bags of litter for disposal.

Master Composter Programme

A Master Composter programme will commence in Portlaw on 15th May. Running over a 4-5 week participants will be trained on all aspects of home composting and, once trained, participants pledge to commit some of their time to help promote home composting and food waste prevention in their local communities. The course accommodates groups of up to 30 people. Participants are provided with a mix of technical information and hands on experience. As part of the programme, a demonstration site is built which is designed to be a local resource where people can shown how composting works and to support other local training initiatives. During the training course participants will be trained in all aspects of home composting from the basics of how it works to how to compost using the different systems (holding bins, wormeries, etc.). Groups wishing to host future Master Composter Programme events are invited to contact the Environment Dept. of Waterford City & County to obtain further information.

West Waterford Festival of Food

The Environment Department of Waterford City & County Council hosted a 'Green Area' at the West Waterford Festival of Food in Dungarvan. This "Green Area" provided a location in which to disseminate information to those attending the festival and hold demonstrations relating to food waste prevention, recycling, composting, furniture up-cycling, etc

Green Schools Awards

The Green Schools awards ceremony will take place on 22nd May in Kilkenny. A total of 21 schools from Waterford City & County will receive awards at this ceremony.

Environmental Education & Awareness in Schools

A Climate Hope forum took place on 26th April in Carrickphierish Library for Green Schools on their Global Citizenship flags. Teachers and pupils learned how we can all work together to create a bigger impact on climate change. Schools from Kilkenny, Wexford and Waterford took part and looked at topics such as Cycling, Plastic (waste, water, marine) and Renewables (energy).
