Major Projects – Progress Report up to January 30th 2018

- 1. Greenway:-
 - All planned civil works have now been completed.
- 2. City Centre Rejuvenation Works:-
 - Works for the new street lighting in John Street, Applemarket and Lady Lane on-going. Existing lighting poles in John Street are being removed and paving at those locations patched following installation and testing of new building mounted lights.
 - Work in Arundel Square is progressing. Works to south end of the Square are progressing with a view to completing works by early February in this area
 - The works on Michael Street North, originally scheduled to begin in 2018, have been completed. Work on Michael street South has begun.
 - The entire works are all scheduled to be substantially completed in April 2018, ahead of the previously programmed June completion date. The programme for the works is as follows:-

Contractors Programme

- Work on the detailed design of the City Centre Access part of the Rejuvenation project is ongoing. An interim scheme in the Manor Street/ Poleberry /Bath Street to allow for the implementation of the new one way system was implemented in January and appears to be working satisfactorily.
- This construction contract for the Hennessey's Road/Browns Lane/Castle Street Scheme is out to tender at the moment and will commence construction in March/April. Demolition of buildings as part of this scheme will be completed by the end of February.

- 3. North Quays:-
 - The CE's Report on the SDZ Draft Planning Scheme went to a workshop with the Members on January 29th.
 - The CPO for the lands associated with the North Quays development had an Oral Hearing on October 24th with An Bord Pleanala and the outcome is awaited.
 - A proposal under Part VIII of the Planning and Development Act in respect of the demolition of the Hennebique Building was approved by Council on January 29th.
- 4. Work has commenced to prepare plans for the construction of the recently funded access roads in Gracedieu and Kilbarry under the LIHAF scheme. The Chief Executives Report on the Part VIII planning process was adopted by the Metropolitan Members in December. It is anticipated that the two access roads will progress to construction stage by the end February 2018.


Planning Applications Received – Countywide

Planning applications received in 2017 amounted to 908, which resulted in an increase in planning applications of 57 applications compared to 2016; in percentage terms this represents a 6.7% year on year increase in planning applications received.

47 planning applications were received in the month of January 2018 (to 26th). This compares with 39 planning applications received in the same period in 2017.

Planning Decisions 2018 – Countywide

To the 26th January 2018, 46 planning decisions have been made. Of these, 41 applications were granted and 5 refused, representing a grant rate of 89.1%. Planning application decisions made in the peeriod by decision type are shown below:

Heritage Plan Funding

A funding allocation of €27,000 has been allocated by the Heritage Council to five projects under the County Heritage Plan in 2018. These include habitat mapping along the River Blackwater and River Bride, 1918 Centenary Commemoration Programme, support of community archaeology projects, publication on Heritage and History of the Greenway and Heritage and Biodiversity Week events.

Waterford Area Partnership have been awarded the SICAP contract for 2018-2022. Formal agreement signed on 18th December.

Waterford Rural Development programme:

The first RDP payment issued on 22nd December 2017 in the sum of $\leq 111,069$. The creation of a number of new jobs was confirmed. A further payment is expected to be made by the end of January in the sum of $\leq 62,517$. A further 22 projects will progress to application stage following consideration of Expressions of Interest at the December LCDC meeting.

Comhairle na nÓg:

The plan for the 2018 programme is complete. The Comhairle Coordinator and Community Dept. liaison have met regarding the 2017 Annual report and 2018 Funding Request which has been submitted to the Department – currently awaiting feedback from Department.

Pride of Place:

National Pride of Place Coordinator meeting held in January where the 2017 programme was reviewed and 2018 programmed planned. The entry for the 2018 National Pride of Place awards will be Tramore and Waterford Arch Club. Work with this group will commence in February/March 2018 with a view to compiling a comprehensive entry to the competition.

JPC:

The first meeting of the JPC Strategic Steering & Oversight Committee was held on 30th January to discuss Action Plan for 2018.

Waterford Age Friendly Programme:

The work of the action groups is underway with significant progress on delivery of thematic area actions expected early in 2018. Priorities for Q1 2018 include the identification of core projects each thematic lead will develop during the year and the establishment of an Older Persons Council.

RAPID:

New RAPID grant scheme for disadvantaged urban areas. Successful applicants notified of grants.



Environmental Complaints

The following graph shows the top 10 category of complaints received. Environmental Inspectors continue to investigate complaints received and monitor illegal waste issues, littering, fly-tipping and illegal signage and issued litter fines where offences are detected. The Waterford City & County Councils Dog Warden continues to investigate all control of dogs issue throughout the City & County.

Environmental Education & Awareness

Community Clean-Ups

Waterford City & County Council continues to offer assistance throughout the year to the general public every spring/summer season to clean up litter and illegally dumped waste from their local environs e.g. approach roads, local beauty spots, beaches and general public areas. National Spring Clean will take place during the month of April; 2018 is the 20th year of National Spring Clean.

Green Flag Programme

As part of Waterford City and County Council's support of the An Taisce's Green Flag programme for schools, work is ongoing with schools to provide advice and support them in their work. Renewal assessments for the next flag have already begun and will continue until the end of March. A total of 51 schools are due to renew their Green Flag this school year. A Green Schools Roadshow was organised with An Taisce for 30th January for all schools working on a Global Citizenship themes.

Workshops for Secondary Schools

Secondary schools involved in the Green Schools programme are being offered environmental workshops funded by Local Agenda 21. The schools can choose the theme of the workshop e.g. waste, energy, climate change, water, biodiversity, etc.

Local Litter Awareness Grant

In order to facilitate community and school clean ups during National Spring Clean and over the Summer, this grant will be advertised in early February, with a deadline of early March for applications. This will enable notification to be issued to successful applicants and payment of the first half of the grant to be paid out by April; projects can begin from the second quarter of 2017.

Local Authority Prevention Network (LAPN)

A joint application was submitted by Waterford City & County Council and Wexford County Council for the funding of a food waste prevention initiative under a Local Authority Prevention Network (LAPN). This food waste prevention project was approved for funding for $\leq 11,285$. As part of this project, Stop Food Waste workshops were allocated to groups to educate participants about food waste prevention. These workshops help participants to cut down on their food waste (and costs; it can save a household up to ≤ 60 a month). A short animated video produced as part of this project was launched on 19^{th} January and will appear in cinemas for 10 weeks from mid January. This will also be used on social media, on YouTube, in schools, etc in both Irish and English. Images from this video will also be used as a theme for schools competitions, use at food waste prevention events, etc.

Local Waste Prevention Grant

A waste prevention budget is set out in the Southern Region Waste Management Plan and amounts to €16,194.15 for Waterford City & County Council (it was agreed regionally to allocate a minimum spend of €0.15/inhabitant on local prevention projects). In 2018 30% of this waste prevention budget has been allocated as a small grant to communities for waste prevention projects. This grant will be advertised in late January with a closing date for application of early March.

Food Waste Prevention Grant

A joint application was submitted by Waterford City & County Council and Wexford County Council for the funding of a food waste prevention initiative under a Local Authority Prevention Network (LAPN). This food waste prevention project was approved for funding for €11,285. As part of this project, Stop Food Waste workshops have been organised to educate participants about food waste prevention. A short animated video produced as part of this project will be launched and appear in cinemas in mid January. This will also be used on social media, on YouTube, in schools, etc in both Irish and English to raise awareness about food waste prevention. Images from this video will be used in competitions for both primary and secondary schools, use at food waste prevention events, etc.

Roadside Litter

A campaign re roadside litter will be launched in February to encourage drivers to bring their litter home with them rather than throwing it from the car. This will include signage, social media and press, etc as well as projects with two Tidy Towns groups on reusable cups in order to reduce the number of disposable cups found as litter.

Entente Florale 2018.

Dungarvan, Co Waterford and Inistioge, Co. Kilkenny have been chosen to represent Ireland in the Entente Florale 2018 competition. Entente Florale is a Europe wide competition for villages, towns and cities which was originally established in 1975, currently 9 European countries take part.

Dungarvan was selected on the basis of its high scores in Tidy Towns competitions over the last number of years and on the recommendation of the 2017 Tidy Towns adjudicators who assessed the town for the national competition.

Entente Florale raises awareness of the importance of the green environment to the quality of living in participating town; and within its communities, residential, urban and industrial areas. Entente Florale rates this as being very important as populations grow, the density of urban and living areas within Europe is increasing therefore the provision of adequate green spaces and landscaping is necessary to provide a rich environment and to preserve quality of life.

Participation in Entente Florale will represent a great opportunity for Dungarvan and acknowledges all the work put in over the years enhancing the presentation of the town. Previous entrants to the competition have recognised that participation in Entente Florale has given a substantial boost to local tourism industry.

A public meeting is being arranged for March 7th when representatives from the **Department** of Rural and Community Development will provide further insights into the competition and identify the allocated date of judging.

Waterford Energy Bureau

Sustainable Energy Community Initiative

Waterford Energy Bureau are seeking community groups to partake in the SEAI Sustainable Energy Community Initiative. Funding of between $\leq 10,000$ and $\leq 25,000$ is available to develop an energy master plan for year 1 and funding of between $\leq 32,000 - \leq 128,000$ for years 1-3 for other reports / studies. Funding is also available under the initiative for energy efficiency upgrades / installations.
