General Environment Enforcement

Environmental Inspectors continue to investigate and monitor illegal waste issues, littering, fly-tipping and illegal signage and issued litter fines where offences are detected. 
Recent Enforcement Case before Carrick-on-Suir District Court

An elderly landowner was spared a waste management conviction on 17th January at Carrick-on-Suir District court on the provision he paid €3,000 towards the Councils clean up costs.

Waterford City and County Council took a prosecution against the landowner for facilitating the unauthorised management of construction and demolition waste and soil in a protected area adjacent to the River Suir near Carrick-on-Suir. WCCC found that construction and demolition waste had been dumped on the land which forms part of the Lower River Suir Special Area of Conservation prior to July 2022. The landowner for the land in question could not be traced, and the land appeared to be abandoned, but in August 2022, an adjoining landowner paid a contractor to form an entrance ramp to the land with the waste material to provide an additional access to his adjoining land. Subsequent to this, WCCC undertook a cleanup, removing the C&D waste to restore the area to its previous condition.

The adjoining landowner pled guilty to the offence under section 32 of the Waste Management Act, but Judge O'Shea, noting that the defendant had not previously been before the courts, said he would apply the probation act to the landowner and spare him a conviction if he contributed €3,000 to the council's clean-up costs.

Dungarvan:

- New Sensory Play Equipment has been installed in Walton Park.

Climate Action

Climate Action Plan

The Chief Executive's Report and the Draft Climate Action Plan with changes noted on foot of suggestions made in the consultation and the Strategic Environmental Assessment documents are available on Decision Time. Elected members will be asked to adopt the Climate Action Plan on 8th February next and there will be a workshop for elected members in advance of the Council meeting to discuss the Plan and the proposed changes.

Community Climate Action Fund

The deadline for applications for the Community Climate Action fund was 19th January. Nine communities from the Dungarvan and Lismore Municipal District applied for funding. The projects will now be assessed by a team of independent assessors within the Council and the chosen projects will go forward to the Department of Environment, Climate and Communications for final approval. Once approved communities will have 18 months to deliver their project. The total amount to be distributed in this programme is €564,000.

Energy Improvement Projects

- Cappelquinn Library, Carnegie library: Attic insulation completed, heat pump heating system due to be installed.
- Dog Pound: Attic and cavity wall insulation and heat pump have been installed. New windows and doors to be installed by mid March.

EU funding

The Climate Team have been successful in securing €163,000 in funding through the Interreg fund. This fund will further collaboration between large organisations in the City to reduce emissions and put in place governance to achieve the same over 3 years. It will give Waterford an opportunity to learn from other European cities further along the way to becoming a zero carbon city.

Introduction of Deposit Return Scheme

From 1st February, a new Deposit Return scheme will be introduced in Ireland. When you buy a plastic, aluminium or sell drinks container that features the Return logo, you will pay a small deposit in addition to the price of the drink; you will then get this deposit back when you return your empty, undamaged container (to any shop). We have been working with our Communications Section to post on social media and have also created a local case study to make the general public aware of this in the coming weeks.

Green Schools Programme

All Green Schools working on a flag for this current school year must receive a visit and submit an application by 15th March 2024. Green Schools visits are therefore well underway, with schools availing of an assessment visit to their school. Themes range from Litter & Waste to Water and Biodiversity.

Composting for Schools Programme

The 8 Secondary Schools taking part in the Composting for Schools programme are currently working on an action plan to tackle waste within their school and receiving student and staff training. The initial visit was carried out to conduct a waste audit, helping schools to prevent, reduce and reuse their waste, and putting a strong focus on recycling food waste. Schools have also taken part in 5 online sessions to learn more about waste prevention, recycling and composting within a school.

Rubbish Schools Film Festival

The Environment Department is working with Createschool to offer 4 secondary schools in County Waterford the opportunity to participate in the Rubbish Film Festival. The Rubbish Film Festival is a really unique opportunity for Transition Year Students to showcase their creative talents, create awareness on Environmental Issues such as Climate Action and learn some new digital storytelling skills in the process. Each participating school will receive an intensive 2-day workshop on-site in their school from [Createschool](#) to help them gain and/or develop the skills to create their own short ONE MINUTE film or films that will create awareness among their peers on their selected environmental issue. Festival All costs are covered by the Environment Department of Waterford City & County Council.

Tidy Towns Seminar

A Tidy Towns Seminar will be held in Dungarvan on 28th February. All Tidy Towns groups have been invited to attend this seminar and learn more about sustainability in the competition.

Connecting Communities Roadshow

The Environment Department is taking part in a Connecting Communities Roadshow at 7 locations around the county this spring. Currently, other partners at the Roadshow include various WCCC departments, Waterford PPN, Waterford Sports Partnership, Waterford Leader, Waterford Area Partnership, Local Link, HSE Health Promotion, Waterford Volunteer Centre, Community Guards, Fire Service and WWETB, with the idea that the greater the collaboration, the better the attendance at each roadshow. The Environment Departments display will focus on food waste prevention, correct waste segregation and WEEEE.

The dates and locations for February and March are as follows: Lismore: 7th February, Dungarvan: 21st February and Ballymacarbry: 20th March.

Community Clean-Ups

Waterford City & County Council facilitates community clean ups throughout the year to clean up litter and illegally dumped waste from approach roads, local beauty spots, beaches and general public areas. The Environment Department continue to supply bags, gloves and litter pickers from both Dungarvan and Waterford offices to many of the groups taking part, as well as collecting the bags of litter afterwards.
