Féile agus Mórshiúl Naomh Pádraig 2024 Cathair Phort Láirge, 15ú – 18 Márta 2024

Is é atá i gceist leis an imeacht ná Mórshiúl a dhéanann ceiliúradh ar Lá Náisiúnta na hÉireann. Tosaíonn an Mórshiúl ag Lána Penrose agus téann sí trí na Céanna, le críochnú ar an Meal, Cathair Phort Láirge.
