




Community Climate Action Programme Strand 1

...to shape and build low carbon, sustainable communities in a coherent way to contribute to national climate and energy targets...

€564,000 (€24m nationally)




- National programme
- Community Groups
- Fund <u>direct</u> climate action projects
- Receive 100% funding for capital projects
- o Be completed in 18 months
- Supported by Waterford City & Council

Who is this programme for?

Waterford Community Groups





Eligibility

To apply your group must be:

- 1. be a not-for-profit organisation
- 2. be located in the operational area of WCCC
- 3. be registered with a PPN or connected with other collectives such as the Wheel, Tidy Towns and /or a community group with Articles of Association or a Constitution, which hold an AGM, and for which approved minutes are available

Examples of community groups eligible:

- Community groups (e.g. neighbourhood associations, Women's/ Men's Sheds, Community Development Groups etc.)
- Sports Clubs (e.g. GAA, Football, badminton etc.)
- Local charities
- Local environmental groups
- Social enterprises

Communities not eligible:

- Private individuals
- Commercial undertakings (including sole traders)
- Schools, third levels institutions etc.
- National community and environmental organisations





What projects are eligible?

Direct climate action projects which address the five programme themes and national climate targets







1. Community & Energy:

Improving energy efficiency and increasing renewable energy.

Five Programme Themes



2. Travel

Contribute to a reduction in travel related emissions.



3. Food & WasteReduce food waste.



4. Shopping & Recycling Food & Waste

Increase the variety and facilities for reduce, reuse, repair and recycling of materials.



5. Local Climate & Environmental Action

Managing the local physical environment, including in relation to climate action.





Theme	Project examples include but are not limited to:
1. Community & Energy	 small community renewable energy projects (solar, hydro, wind) retrofitting community buildings LED community lighting community EV charging point(s)
2. Travel	 cycle parking improving access to cycle/ walkways community EV charging point(s)
3. Food & Waste	 community gardens/ allotments repair hubs community composting facilities community fridge
4. Shopping & Recycling	 community repair hubs sport reusable kits toy/ equipment library of things water filling stations
5. Local climate & environmental action	 mini forests community gardens/ roof gardens pollinator projects water harvesting climate resiliency projects

What level of funding is available?

Small to big projects - up to €100,000







Project sizes

Small scale projects

Projects valued at **less** than €20,000

[10% ≈ 3-4 projects]

Medium scale projects

Projects valued in the range of €20,000 to €50,000

[40% ≈ 4-5 projects]

Large scale projects

Projects valued in the range of €51,000 to €100,000

[50% ≈ 3-5 projects]

- Groups must self-certify that they do not have the funding available to undertake the work without support, OR alternatively that the support will enable them to undertake more work which they otherwise would not be able to afford.
- This is a reimbursement grant but if groups require bridge financing WCCC can provide that
- Project selection numbers are only an estimate and the final selection may vary





What is funded?

Eligible costs must be:

- Predominantly capital
- For the sole purpose of implementing the project and necessary for delivery
- Verifiable and reasonable
- No duplicate public funding but can have match funding as long as the CCAP funding component can stand on its own merits and be independent of the other funding.
- Must comply with State Aid requirements

Ineligible costs:

- Projects that solely benefit an individual or income generating projects
- Operating costs
- Training, staff costs, travel, banking, legal etc.
- Costs incurred before the Letter of Offer
- When more appropriate funding opportunities already exist

VAT can be included with costs if your group cannot reclaim their VAT





Can a project include more than one action?

Your projects can include a suite of measures, not just one action.



When you are planning your project remember the objective...

All project sizes welcome! ...to shape and build low carbon, sustainable communities...

Programme themes:

- 1. Community & Energy
- 2. Travel
- 3. Food & Waste
- 4. Shopping & Recycling
- 5. Local Climate & Environmental Action

Climate Action:

- Reducing emissions
- Increasing energy efficiency/ renewables
- Increasing/ protecting biodiversity
- Creating local climate resilience
- Reducing waste/ Circular Economy
- Just Transition





Where can projects take place?

Any location that is under the operational area of Waterford City & County and is available to the community.







Project locations

- Community <u>owned</u> building or land
- Community <u>leased</u> building or land (5 years from the end of the project)
- Public space (may need permission)







Strand 1a "Shared Island Community Climate Action"

- €3m available for projects across the whole island of Ireland
- Same objective as strand 1
- Same 5 programme themes as strand 1
- 50% funding must go the northern partner

Key difference: Waterford Community would have a partner group in Northern Ireland.

Communities eligible for strand 1a:

- be a not-for-profit organisation
- be located in the operational area of WCCC
- can be a national community and environmental organisation
- be registered with a PPN or connected with other collectives such as the Wheel, Tidy Towns and /or a community group with Articles of Association or a Constitution, which hold an AGM, and for which approved minutes are available
- have <u>at least one partner organisation in Northern Ireland</u>, Partner organisations must be either
 a:
 - not-for-profit organisation
 - Local Authority
 - o local/ national community and environmental organisation registered in Northern Ireland

Communities not eligible:

- Private individuals
- Commercial undertakings (including sole traders)
- Schools, third levels institutions etc.





How to apply?

1. Contact the Community Climate Action Officer to discuss your project ideas

Design and cost your project (3 quotes)

3. Complete and submit your application form (Deadline – 19th January 2024)





How to apply?



Option 1 - Online application form:

- Complete the online form at https://waterford.submit.com/
- Recommended method
- You can save your form as you go, so you do not need to complete and submit the application in one sitting.
- You will also be able to upload all relevant documentation.

Option 2 – By email/post:

- Download the Word version of the form and submit a typed/ written form with your supporting documentation.
- Email: climateaction@waterfordcouncil.ie
- Post: "Community Climate Action Officer, Climate Action Team, Environmental Department, Waterford City and County Council, The Mall, Waterford".

- Innovation/ Scalability
- Value for Money
- Governance

Section 3 – State Aid Questionnaire

Determine if the funding is State Aid (will depend on the organisation and type of project)

Section 4 – Supporting Documentation

Governance documents, costings & supporting documentation (optional)







How will projects be selected?

To be successful chosen for funding a project would need to first pass the evaluation stage, then the selection stage and finally the approval stage.





How will projects be evaluated, selected and approved?

1. Evaluation by WCCC:

Need to achieve at least 50% and the minimum requirements

2. Selection by WCCC:

Final selection of projects taking account of:

- scores
- the geographical distribution of projects
- the desirability to fund a variety of different projects and across multiple themes
- the contribution of the projects to the climate action objectives of WCCC

3. Approval by DECC:

Decision made by Minister of the Environment, Climate and Communications

Evaluation criteria for strand 1	Weighting	Min. required
Relevance and impact	30%	15%
Innovation and scalability	20%	-
Value for money	20%	10%
Achievability	10%	5%
Partnership approach	10%	-
Governance arrangements	10%	5%
	100%


