Forbairt Eacnamaíoch / Economic Development



The North Quays main contract works are progressing well. The Skerchi barge has relocated to the north side of the river to progress the northern cofferdam construction (gridline C). The fabrication of the superstructure is progressing in Belgium with over 10,000 work hours/ month being expended on its fabrication.

Forty sheet piles for the South Plaza quay wall (S37) are in situ and are currently being driven into position.

Works to complete the train station concourse supporting walls and columns is ongoing and visible in the image.

The road and access infrastructure is progressing well, the first bridge beams have been installed at the western access bridge (S19) and is illustrated in the image above, while the piling for southern bridge abutments to the eastern access bridge (S22) is complete and works are ongoing to the greenway underpasses (S23 & S24), visible below.



The two pumps station contract are c. 90% complete, but the programme has extended into Q2 2024.

Traffic management measures continues to be in place along Dock Road to install sewer and surface water network services. Phase 4 traffic management measures will commence in January 2024 and will progress to Abbey Road / Fountain Street junction. Traffic management details will be circulated in advance on local radio and social media.

Visit Waterford Update





PLANNING APPLICATIONS RECEIVED - COUNTYWIDE

82 planning applications were received countywide in December 2023. This compares with 84 planning applications received for the same period in December 2022.

A total of 997 planning applications were received in the year to 28th December 2023. This compares to 1089 planning applications which were received for the same period in 2022.





Derelict Sites

The activity in recent months has substantially increased with 81 derelict properties identified and on the Derelict Sites Register. Initial engagement with owners or their representatives is key to resolution of the issues of dereliction and to understand the various reasons why the properties are in a derelict stage.

Community Monuments Fund 2024

The Department of Housing, Local Government and Heritage launched a Call for Projects for the Community Monuments Fund 2024 on the 16th November 2023. Funding is prioritised for local authorities, private owners and custodians and community groups for the care, conservation, maintenance, protection and promotion of archaeological monuments.

Total funding available nationally for projects under Community Monuments Fund 2024 will be €7,000,000. The Community Monuments Fund invests in archaeological heritage and helps owners and custodians of archaeological monuments to safeguard them into the future for the benefit of communities and the public.

The core aims of this Fund are the conservation, maintenance, protection and presentation of archaeological monuments. It will:

- •enable conservation works to be carried out on monuments which are deemed to be significant and in need of urgent support
- •build resilience in our monuments to enable them to withstand the effects of climate change
- •encourage access to monuments and improve their presentation.

The Department encourages project promoters to incorporate a traditional skills training element in projects.

The Community Monuments Fund has 3 Streams:

•Stream 1 will offer grants up to €100,000 aimed at essential repairs and capital works for the conservation and repair of archaeological monuments

- •Stream 2 will offer grants of up to €30,000 for development of Conservation Management Plans/Reports that are aimed at identifying measures for conservation of archaeological monuments and improving public access.
- •Stream 3 will offer grants of up to €30,000 for enhancement of access infrastructure and interpretation (including virtual/online) at archaeological monuments.

The Community Monuments Fund provides funding for projects in relation to:

- •Archaeological Monuments that are included in the Record of Monuments and Places (RMP) under the National Monuments Act 1930 (as amended)
- •Archaeological Monuments that are identified in the Sites and Monuments Record compiled by the National Monuments Service.

Eligible projects will be drawn from the following categories:

- •projects proposed by a Local Authority in relation to archaeological monuments in public ownership, where a clear heritage focus and community or public benefit has been demonstrated
- •projects proposed by a Local Authority on foot of applications from private applicants who are the owners or custodians of relevant archaeological monuments where there is a tangible public benefit
- •projects with a clearly defined heritage focus and community or public benefit proposed directly to the department by a State-funded organisation working in the heritage area.

Last date for submission of projects for consideration is close of business on the 14th of February 2024

Planning and Development Bill 2023

Government published the Planning and Development Bill 2023 on the 21st of November.

At over 700 pages in length, Minister O'Brien describes the legislation as "the cornerstone for Irish planning for the coming decades". The Draft Bill which was published last January has undergone months of Oireachtas scrutiny and stakeholder engagement. And the recently published Bill is the culmination of an intensive review lead by the Office of the Attorney General.

The current legislation has been subject to a complete review to identify reforms to deliver key infrastructure in housing, transport and renewable energy.

Key reforms include:

- •Improved consistency and alignment throughout all tiers of planning;
- •Significant restructuring and resourcing of An Bord Pleanála, which will be renamed An Coimisiún Pleanála;
- •Increased certainty across the planning system through the introduction of statutory timelines for decision-making, including for the first time, for An Coimisiún Pleanála;
- •New strategic ten-year Development Plans for Local Authorities;
- •Reform of planning Judicial Review, including the introduction of a Scale of Fees and Environmental Legal Cost Financial Assistance Mechanism; improving access to justice whilst regulating excessive legal costs; New provisions for Urban Development Zones, underpinning key growth areas.

Forward Planning

The final map of lands identified as being in-scope for the RZLT has now been published by Waterford City and County Council and all local authorities across the country. The final map has had regard to the determinations of An Bord Pleanála on all appeals and recent circular letter from the Department of Housing, Local Government and Heritage. The final map is available on the council website.

A new phase of consultation relating to the draft revised annual map for 2024 will begin on 1st February 2024. This consultation process will facilitate landowners to make written submissions to the local authority and make subsequent appeals to An Bord Pleanála with regard to the content of the draft revised annual map. This revised annual map will consist of the recently published final map along with highlighted proposed exclusions and/or inclusions.

Seirbhísí Pobail / Community Services

LOCAL ENHANCEMENT PROGRAMME 2024

Waterford City and County Council (WCCC) has been allocated capital funding of €190,945.68 under the Local Enhancement Programme (LEP) 2024 by the Department of Rural and Community Development (DRCD). This total amount comprises of:

•€159,121.40 capital funding for the LEP main funding stream to use towards carrying out necessary repairs and improvements to facilities, energy efficiency type projects, purchase of equipment etc.

•€31,824.28 capital funding ring-fenced for Women's Groups. The LCDC is asked to identify Women's Sheds, Groups and Networks in their areas, and to use this ring-fenced funding to provide support and assistance same.

It should be noted that Women's Sheds, Groups and Networks are not precluded from applying for the general funding available for community groups under the main fund.

The grant will be open for applications in the coming weeks.

RURAL DEVELOPMENT PROGRAMME:

Payments on the current LEADER programme are progressing well and two projects will continue into 2024.

The Local Development strategy has been approved by the Department and the contract for LEADER 2023 – 2029 has been signed by Waterford Leader Partnership, Waterford LCDC and the Local Authority and awaits ministerial sign off presently. The budget for the new LEADER Programme 2023 to 2029 is €6.1m with €4.5m allocated to projects. Supplementary funds may be allocated over the course of the programme.

COMHAIRLE NA NÓG:

The topic for 2024 has been identified by the young people and this will now be the basis for work in the coming year. The Podcast series on the young peoples chosen topic is fully complete and published. The AGM took place in November in the Tower Hotel, Waterford with a huge attendance. The young people continue to participate in their nominated local and national committees.

WATERFORD AGE FRIENDLY PROGRAMME:

Delivery of the year 1 action plan has begun with six of the seven Implementation Subgroups (the majority having met multiple times). The remaining group will have initial meeting in early December. The new Age Friendly Alliance is due to have its initial meeting during during early December.

WELL WATERFORD (LCDC SUB-GROUP)

Connecting Communities

The Community Team are leading out on a 'Connecting Communities' Roadshow in February 2024 to deliver key messages on service delivery at local level, promote community engagement and to create community connections. This is an opportunity for a collaborative approach on community engagement and participation for community facing departments of WCCC and its key partners.

We have a working group in place which includes colleagues from Community, Environment, Climate Action, Libraries, Culture, Waterford Leader Partnership, Waterford Area Partnership, PPN and Waterford Sports Partnership at present and hope to expand on that before the first roadshow on the 7th February. Dates and venues of the Connecting Communities Roadshow will be publicised in the new year.

WHO Healthy Cities Conference

"Health and Well-being for All: celebrating 35 years of the Healthy Cities movement" was attended by Waterford Council. The business meeting had a strong focus on the wellbeing economy, planetary health and learning from experiences. Cork Healthy Cities and Cork City Council presented on several fronts and the inputs and parallel sessions have laid a strong platform for other Cities and Healthy Ireland City & County Programmes to present at future WHO events. Our aim in 2024 is to re-establish Waterford to be an official member of the network.

General Update

- •INTEREGG Funding for Waterford is being applied for through a European consortium bid. The application is being processed currently. A meeting took place on the 22nd of November in Amsterdam in which the next stages of the application were processed. The next meeting will take place in January. After which we will be identifying a stakeholder group to represent Waterford.
- •We are finalising our funding commitments with the Healthy Ireland fund for 2024. Some projects will carry over from 2023. Reporting to the department will begin in January 2024.
- •Several areas are being highlighted with a view to provide support throughout 2024. This will lead to a targeted approach to Community Wellbeing and capacity building training for community and voluntary groups.
- •The Well Waterford Strategic Group met on the 5th of December where the Terms of Reference were finalised.
- •We will be arranging a meeting to give elected members input in January & February of next year to Healthy Waterford projects.

WATERFORD LOCAL COMMUNITY SAFETY PARTNERSHIP (WLCSP):

Community Safety Innovation Fund Projects:

The lease in relation to the house and half the adjacent allotment site at Colligan View Dungarvan has now been finalised by Waaterford City & County Council and the WWETB. The WWETB have commenced the process of alarm installation, electrical upgrade and the furniture & equipment fitout for the centre. The additional fencing and access changes agreed have been priced and are expected to be completed in early January 2024. It is intended to now revert to the residents in January 2024 also, now that we have definitive agreements, information and plans.

The drafting of the North West Suburbs Community Action Plan is well underway. The preliminary review of the 'drop in' consultation held in the Carricphierish Library on Monday 20th November 2023 was that public want to see more things for young people to do, more supports like the library, more parks & outdoor spaces, a bigger focus on community safety, schools in the area being praised and protected and access to playgrounds for kids in the area. An online survey finished on Friday 15th December with numbers in excess of 200 having completed it at 13th December. Currently, consultations are taking place with stakeholders and first draft is expected by February.

The next meeting In relation to the Portlaw Engages Youth Project, with the Chair, Youth Justice, Gardai, WSTCYS, WWETB and TUSLA is scheduled for 7th February 2024.

Preparatory work is in hand for the two successful 2023 Grant Applications to the Community Safety Innovation Fund, Consent Matters and A Community Safety Warden Initiative for Waterford City and these will be advanced with haste, in January 2024.

LCSP Small Grant Fund

The twenty five successful applicants in the Department of Justice Waterford Community Safety Partnership Small Grants Fund, have had their allocations advanced with innovative projects and initiatives that respond to the needs identified in the WLCSP Community Safety Plan 2023-2028, underway.

WLCSP Meetings:

The WLCSP Plenary Meeting took place on 4th December at 630pm in the Civic Offices, Dungarvan and items on the Agenda included; presentations from Property Marking Ireland, the Garda Cyber Crime Bureau, and Restorative Justice in a Community Safety sense. The next Meeting is scheduled for Monday 12th February 2024 at 5pm in the City.

UKRAINIAN COMMUNITY RESPONSE FORUM:

The Ukrainian CRF is in place to assist with housing, supporting and integrating Ukrainian refugees into our communities. All key agencies are working in collaboration to provide services and supports to all Ukrainians arriving into Waterford.

To date over 101,600 (@ 8th December) temporary protections have been granted to Ukrainians arriving to Ireland, with in excess of 2,758 of those registered here in Waterford.

Waterford City & County Council have provided temporary accommodation to over 2,051 Ukrainian refugees in the Council run rest centres and have matched over 1,954 of those with pledged and Council sourced accommodation.

The 'offer a home' pledge call for vacant properties has been relaunched with over 265 Ukrainians being accommodated in pledged accommodation to date. Any queries on same should be directed to offerahome@waterfordcouncil.ie or 058 22059

Waterford Area Partnership continue to provide supports to Ukrainians on community integration. Language classes for adults that recommenced in September have now reached capacity in Dungarvan and Waterford City. As a result we are currently mapping all language services, in consultation with the WWETB, to ascertain if other services can be utilised to meet the demand.

School places have been provided for all arrivals who wish to take up education and REALT continues to work on sourcing school transport for rural accommodation areas. GP places are limited but HSE team continue to source access for those in pledge accommodation.

PRIDE OF PLACE:

The National Pride of Place awards event took place in Armagh on November 10th where CAPE-ability Lismore (winners of the overall PPN award) and the Larchville/Lisduggan Residents Group (nominated by the Housing Dept.) represented Waterford. Congratulations to the Larchville/Lisduggan Residents Group who won their category.

The overall winner of the PPN Community & Voluntary Awards for 2023 were RENEW Enterprises, who will represent Waterford at the 2024 national Pride of Place awards.

MIGRANT INTEGRATION:

The last Migrant Integration Strategy Meeting took place on the 1st November 2023 and the next meeting is scheduled to take place on the 24th January 2024. A review of the Migrant Integration Forum is currently taking place with an addendum to the Migrant Integration Strategy currently being prepared to include the Ukrainian community in the strategy.

The Council's Integration Support Team is in place since early December. This team will take the lead in co-ordinating supports and services for International Protection applicants, those with refugee, subsidiary protection or permission to remain status, programme refugees and beneficiaries of temporary protection.

SICAP

Work in ongoing with Waterford Area Partnership continuing to implement the SICAP programme on behalf of the LCDC. SICAP Budget allocations for 2023 and the budget for Waterford City & County (Lot 24-1) is €1,319,399 excluding the Ukrainian budget allocation which has been set as €232,758 by the Department.

The contracts for the SICAP 2024+ were signed on 14th December by Waterford Area Partnership, Waterford LCDC and Waterford City & County Council.

TRAVELLER INTERAGENCY GROUP (TIG)

The Community Department continue to support the Waterford TIG which continues to meet regularly. The next meeting is scheduled to take place on the 31st January 2024.

LOCAL ECONOMIC & COMMUNITY PLAN (LECP)

The 2023 – 2029 LECP was adopted at the Plenary Council meeting on 14th December and will be available in both Irish and English on the Council's website in the new year.

CLÁR MEASURE 1 - DEVELOPING COMMUNITY FACILITIES & AMENITIES

A total of 9 applications were received 8 of which met the criteria and were submitted to the DRCD in early June. Formal notice of the successful projects and funding under Measure 1 is awaited.

FESTIVAL GRANTS 2024

18 community festival grant applications were approved for 2024 at the December plenary Council meeting totalling €146,000. The Festival & Events Grants Scheme aims to help support events across Waterford which help contribute towards making Waterford a more vibrant and sustainable place.
