|  | <ul style="list-style-type: none"><li>• Following low temperatures and heavy rainfall events there is an increase in potholes. Crews are dealing with potholes in the District. Continue to report on CRM and to District Engineer. Potholes will be filled as soon as possible.</li><li>• Road lining ongoing throughout the District.</li><li>• Davitts Quay – Further cobble lock repairs underway.</li><li>• Litter and Dog fouling should be disposed of correctly and we would encourage community groups and public to be involved throughout Towns and Villages.</li><li>• Spraying is limited in the District and only undertaken where necessary for major weed control. Any communities or groups wishing to assist with weed control would be greatly appreciated. This would reduce spraying.</li><li>• Hedgecutting is not permitted until September as per Wildlife Act. Landowners should continue to check their boundary hedges and trees in front of public roads that may cause road safety issues. Overhanging branches can become a hazard and hedges can cause visibility constraints. Landowner co-operation to date is much appreciated.</li></ul> |
