Forbairt Eacnamaíoch / Economic Development North Quays

The North Quays main contract works programme is significantly advanced and progressing well. The substructure works for the Sustainable Transport Bridge is continuing, the first of four piers is now visible within the most southerly cofferdamThe fabrication of the steel deck superstructure in Belgium is c. 75% complete. The pile support slab for the South Plaza is substantially complete.

The Transport Hub building concourse and the support walls for the station concourse and columns are substantially complete, with works continuing on the station platforms. Works have also progressed to installing the bridge/ concourse precast beams and external lift shafts.

Road and access infrastructure is progressing well, with works continuing on the various bridge structures, in particular with western access bridge and greenway underpasses.Traffic management measures continue to be in place, with works continuing along the median at Dock Road / Fountain Street.


Pump Station

TOURISM

Visit Waterford Update

Membership increased to 55: Following consistent efforts from Visit Waterford and the establishment of a membership sub-committee member numbers are growing steadily.

Increased online visibility and engagement: in a recent report on 2023 activity VW highlighted that Engagement across all Visit Waterford online platforms increased significantly: oWebsite traffic increased by over 35% resulting in over 100,000 users oFacebook Followers: 31,000 (+7%) oInstagram Followers: 8,410 (+17%)



New York Times Article: VW commissioned the creation of a video showcasing the recent awards and accolades, including Waterford featuring in the New York Times Top 52 places to go in 2024, won by the county. This video was sent to all VW members for them to use and issued to the media with a press release promoting the Best of Waterford experience. As a result, VW was featured in Hospitality News, Dining in Dublin and by Pòl O Conghalie on The Today Show.

Winter Ad Campaign: Jan – March

Paid ads included 2 social uplift features on the Irish Independent with a guaranteed reach of 160,000 per video. The first video showcased the tourism offering in Waterford City and brought audiences to the Best of Waterford experience on the Visit Waterford Website. The second showcased the county and brought visitors to the explore page on the VW website. VW also ran a print ad in the Irish Independent Spring Supplement. A further digital ad will be released on March 24th. Visit Waterford also had radio ads running on Beat and Today FM. Visit Waterford are currently running a competition on Lorcan Murray's Classic Drive for a 2 night stay, B&B and dinner on one evening at The Tower Hotel.

Portia Jones-Travel Goals Podcast

VW worked with Fáilte Ireland and Tourism Ireland to welcome Portia Jones to Waterford, Portia visited a number of VW members during her visit including, Waterford Treasures, Sólás na Mara, Waterford Distillery and Mount Congreve Gardens. She produced a 2 part podcast as a result of her visit. VW have established a working group to facilitate a coordinated welcome for cruise ships to Waterford, ensuring passengers can experience as much of Waterford as possible during their visit. The group includes representatives from VW, WCCC, Port of Waterford, Bus Eireann, Excursions Ireland, Volunteer Waterford and the Harbour Master in Dunmore East. Actions have been agreed and the group are working together to deliver clear communications and transport options to passengers as well as ensuring they have a warm welcome through the Waterford Ambassador Programme.

Waterford's St. Patrick's Day Festival 2024

VW worked with WCCC to promote the four day St. Patrick's Day Festival in Waterford City. As part of the promotional activities VW ran a number of international ad campaigns across digital platforms reaching approx. 162,000 people across North America, UK, France and Germany. The domestic campaign included digital ads, competitions and a press release. As a result of the press release The St. Patrick's Day Festival was featured in a number of regional and national publications, including Irish Country Magazine, The Irish Star and Waterford Live.

The next Economic Development & Enterprise SPC will be held in October 2024.



PLANNING APPLICATIONS RECEIVED – COUNTYWIDE

71 Planning applications were received countywide in March 2024. This compares to 83 planning applications received for the same period in 2023.

A total of 215 planning applications were received in the year to 31st March 2024. This compares to 220 planning applications which were received in the same period in 2023.



54 Planning applications were granted in March 2024 with 7 applications refused.

Derelict Sites

The Derelict Sites Team are currently dealing with 280 properties that are considered either derelict or potentially derelict. The activity in recent weeks has substantially increased with 82 derelict on the Derelict Sites Register. Initial engagement with owners or their representatives is key to resolution of the issues of dereliction and to understand the various reasons why the properties are in a derelict stage. To date we have 280 Derelict Site files open.

The level of activity in the property market for vacant and derelict properties has increased and of the properties we have identified as derelict, several of them have been brought to the market and some are at 'to let'/ 'sale agreed' stage. We continue the engagement with the new owners of those properties to ensure they are aware of their responsibilities under the Derelict Sites Act, 1990. Due to the Vacant Property refurbishment Grant, there is a noticeable increase in the number of derelict and vacant properties on the market at the current time.

One property was removed from the Derelict Sites Register in March. The derelict sites team successfully worked with the property owner to bring this property back out of dereliction.

COMPULSORY PURCHASE ACQUISITION OF DERELICT SITES (CPA)

There were 2 CPA's initiated in March and publicly advertised. The deadline for submissions expires at the start of April. The Council will move to the vesting process where applications for registration of title will be made to the Property Registration Authority. In April, we are commencing work on three further CPAs.

DERELICT SITE LEVY

Determination of valuations on the derelict sites which are on the Derelict Sites Register has commenced and notices have issued to 58 property owners. Eight properties have appealed the valuation to the Valuation Tribunal and a decision is awaited. The levy is an annual levy while the property remains on the Derelict Sites Register and amounts to 7% of the value of the property, on an annual basis. This will be further progressed in 2024.

Heritage Officer Report

Decade of Commemorations

Waterford's Two Civil wars- Armed conflict and national strife in Waterford 1922-1924 a publication by Dr. Pat McCarthy will take place on Wednesday April 3rd in the Garden Room of Waterford Medieval Museum. The book was funded through the Department of Tourism, Culture, Arts, Gaeltacht, Sports and Media's Decade of Commemorations Fund. The Department have allocated €15,000 for the 2024 Commemorations Fund which will be allocated to support of film and publications and a programme celebrating the Irish language in the development of the Free State in 1924.

Heritage Plan Grant Scheme

All four projects submitted to the Heritage Council's Heritage Plan Fund have been successful and funding has been allocated.

Community Heritage Grant Scheme 2024

Over 10 applications have been submitted from community groups across the county for the Heritage Council's Community Heritage Grant Scheme. The fund is open to community/voluntary and not-for-profit organisations for heritage projects which must be completed by 15th of November 2024. Last year, seven Waterford-based projects were funded through the scheme.

Community Monuments Scheme

Six applications have been submitted from projects across the City and County under the Community Monuments Scheme 2024 which provides funding for the conservation and interpretation of archaeological sites and monuments pre-1700. The outcome of the application process will be known by end of April.

Conservation Officer

Waterford receives €506,693 in funding for Built Heritage

Malcolm Noonan TD, Minister of State for Heritage and Electoral Reform at the Department of Housing, Local Government and Heritage has announced funding under 2 schemes for Protected Structures and historic buildings - the Built Heritage Investment Scheme (BHIS) 2024 and the Historic Structures Fund (HSF) 2024.

In Waterford, funding of €242,400 will be provided for 27 projects for private and public buildings in the city and county under the BHIS scheme. This will support works such as the repair of historic roofs, walls and chimneys, repair of joinery and repair of historic stained glass. This funding also includes €73,793 which has been ring-fenced specifically for thatch house projects.

Under the Historic Structure Fund €264,000 has been allocated for 4 projects.

Seirbhísí Pobail / Community Services

COMMUNITY GRANTS

Waterford City and County Council (WCCC), at its plenary meeting on 14th March 2024, approved 288 allocations under the Supporting Waterford Communities Fund 2024. The scheme provides grant aid assistance to community groups, residents associations and sports clubs who are engaged in community activity, providing community services or carrying out improvement works. The total fund for 2024 was €241,430. Waterford LCDC, at at its meeting on 14th March 2024, approved 164 allocations under the Local Enhancrment Programme (LEP) 2024 General Fund (total fund of €153,405.12) and a further 26 allocations under the ring fenced Women's Fund (total fund €31,824.28).

The LEP is funded by the Department of Rural and Community Development and administered by Waterford LCDC / WCCC. It's aimed at supporting groups, particularly in disadvantaged areas, with minor capital works and improvements to their facilities, and the purchase of equipment for community use. The Community Recognition Fund 2024 was launchted by Minister Heather Mumphreys on the 15th March.Once finalised, details of the fund will be included on the Council's website and communicated via the PPN and the Council's social media fora.

LEADER 2023-2027

Applications for the first targeted call were due at 12 noon on Thursday, 14 March 2024.Based on engagements the current estimate is 7 projects.The Evaluation Committee convened on 27 March 2024 and the recommended projects will be submitted to the LAG Meeting of 11 April 2024. The second deadline is: 10 May 2024 (12 weeks for works projects) Of the 63 EOIs received, 12 were found to be ineligible. The list of ineligible EOIs was submitted and will be reviewed at the next LCDC/LAG meeting.

LEADER 2014-2022

Inputs were submitted for the Annual LEADER Programme Report. There are currently five projects of which two are about to closed out.

ST. PATRICK'S PARADE AND FESTIVAL

A post event report for St. Patrick's Day Parade and Festival 2024 is being compiled and will be available at the next plenary meeting. The Festival programme included the parade, 30 live music events, cultural attractions, historical events and family fun activities. Initial feedback from the general public, commercial sector and partner organisations has been very positive.

COMHAIRLE NA NÓG:

The topic for 2024 has been identified by the young people and this will now be the basis for work in the coming year. The Podcast series on the young peoples chosen topic is fully complete and published. The AGM took place in November in the Tower Hotel, Waterford with a huge attendance. The young people continue to participate in their nominated local and national committees.

It is evident that Healthy Waterford has emerged as a pioneer in promoting and advocating for a healthier and happier community. It's efforts and initiatives have not only improved the physical health of individuals but have also positively impacted their mental and emotional well-being.

KEY PROJECT SPOTLIGHT – SOCIAL FARMING

Thanks to a robust collaboration among stakeholders, the council and these groups have successfully formed positive relationships. 8 Social Farming Placements took place, one day a week, for 12 weeks. 9 participants took part in the placements and 100 Social Farming days were delivered. Social Farming provides outcome focused placements for people accessing support services. The participants that attended the farms as part of this funding came from Intellectual Disability services. This enables the participants do normal everyday activities that we all do. The participants also helped out prepare for a local event which gave them the opportunity to work with local people which they may not have met otherwise. It is all the time integrating people with ID in our community.

NEW INITIATIVE - MINDING YOUR MENTAL HEALTH MESSAGING FOR WATERFORD GAA CLUBS

Initiated in partnership with the HSE Connecting for Life Team in South East Community Healthcare, the signage highlights ways that you can mind your mental health and promotes the services available if you need to access support. The signage was developed in collaboration with Healthy Waterford/WCCC, Mental Health Ireland and the Waterford GAA Health and Wellbeing Committee. 52 signs will be delivered to GAA clubs and a launch took place recently. It is the intention of the Waterford GAA health and Wellbeing committee, supported by Healthy Waterford, to continue this action throughout 2024 and embed the signage initiative.

NEW INITIATIVE – GROW IT FORWARD

Over 450 packs of food growing equipment were distributed. This has over 2000 packets that will support local communities to grow their own food. This will entail a 12-week programme of education. GROW it Forward is a food education & sustainability programme designed to educate, inspire and empower individuals to grow, share and understand how their local action can deliver global impact. GIY & Healthy Waterford will undertake pre and post programme evaluation to understand the Food Empathy impact of GROW it Forward. Food Empathy are the changes in knowledge, behaviour and attitude that happens when people start to grow some of their own food.

SLÁINTECARE HEALTHY COMMUNITIES PROGRAMME (SHCP):

•Work continues on progressing the various projects under the Sláintecare Healthy Communities Programme with two seed funded projects in 2023 being completed and other 2 close to completion.

•The open competition for the Seed Fund in 2024 is advertised on the PPN website with the deadline for applications being the 5th April 2024.

•Ongoing work continues with community groups, and all funding applicants will be contacted to discuss their projects in more detail.

WATERFORD LOCAL COMMUNITY SAFETY PARTNERSHIP (WLCSP): COMMUNITY SAFETY INNOVATION FUND PROJECTS:

On the two successful 2023 Grant Applications to the Community Safety Innovation Fund, the recruitment process has been initiated for a Tackling Sexual Violence & Harassment (TSVH) Project Officer for the 'Consent Matters' Project is with HR in Waterford City & County Council.

WLCSP MEETINGS:

The next WLCSP Plenary Meeting, which is a public meeting is scheduled for Monday 8th April 2023 at 5pm in the Park Hotel, Dungarvan. A Steering & Oversight Group Meeting took place online on Thursday 28th March 2024. WLCSP is participating in the WCCC 'Connecting Communities' initiative.

WLCSP Co-ordinator attended the Domestic, Sexual, and Gender Based Violence – Cross Border Sharing Learning Workshop in Drogheda on 12th March 2024, and prepared a briefing for the Partnership.

The Chair, Co-ordinator and Partner members attended the Anti Racism Symposium on 6th March 2024, where the Chair presented on the Community Safety Plan in relation to racism. The Chair, Sean Aylward, & Eddie Mulligan, Co-ordinator attended the Launch of the Garda Youth Awards on 1st March 2024.

UKRAINIAN COMMUNITY RESPONSE FORUM:

The Ukrainian CRF is in place to assist with housing, supporting and integrating Ukrainian refugees into our communities. All key agencies are working in collaboration to provide services and supports to all Ukrainians arriving into Waterford. To date over 105,500 (@ 24th March) temporary protections have been granted to Ukrainians arriving to Ireland, with in excess of 2,904 of those registered here in Waterford. Waterford City & County Council have provided temporary accommodation directly to over 2,110 Ukrainian refugees in the Council run rest centres and have matched over 1,586 of those with pledged and Council sourced accommodation. Over 760 Ukrainians are accommodated in pledged properties throughout Waterford currently with new pledges required on an ongoing basis. MIGRANT INTEGRATION:

The last Migrant Integration Strategy Meeting took place on the 27th March 2024 and the next meeting is scheduled to take place on the 29th May 2024. A review of the Migrant Integration Forum is currently taking place with an addendum to the Migrant Integration Strategy currently being prepared to include the Ukrainian community in the strategy and should be completed shortly.

SICAP

Work is ongoing with Waterford Area Partnership who continue to implement the SICAP programme on behalf of the LCDC. SICAP Budget allocations for 2024 Waterford City & County (Lot 24-1) is €1,408,392.00 The 2024 budget for 'New Arrivals' is €246,807.00.The contracts for the SICAP 2024+ were signed on 14th December by Waterford Area Partnership, Waterford LCDC and Waterford City & County Council.The SICAP sub-committee met on 7th March last. Waterford Area Partnership gave presentations on the 2023 End of Year Report and the 2024 Annual Plan. The annual plan was subsequently approved by the sub-committee. KPI Targets as set out in the tender process are 79 for Goal 1 and 949 for Goal 2. The subcommittee decided on the following local priority target groups "living with disability", "people living in jobless and low paid households" and "people living with disadvantage". Percentage targets for the local priority target groups will be negotiated with Waterford Area Partnership in the coming weeks.

CLÁR MEASURE 1 - DEVELOPING COMMUNITY FACILITIES & AMENITIES

The Letter of Offer was issued by the DRCD and the Acceptance of Funding Agreement was returned to the Department on 12th February. All successful projects which received funding were notified and sent the terms and conditions in 15 relation to the scheme.

ENVIRONMENTAL EDUCATION & AWARENESS

Green-Schools promotes long-term, whole-school action for the environment Green-Schools with primary and secondary schools. There are 61 schools in Co. Waterford due to renew their Green Flag this year. A renewal visit must take place before a school submits a renewal application form for their renewal Green Flags (Energy, Water, Travel, Biodiversity and the Global Citizenship themes). Renewal visits are carried out by the Environment Awareness Officer. The purpose of the visit is to demonstrate that the school has an active Green-Schools programme in operation and has been maintaining previous themes in addition to working on the current theme. Schools applying must first complete an assessment visit from the Environment Awareness Officer before submitting their renewal application. All Green Schools working on a flag for this current school year must receive a visit and submit an application by 15th March. Themes range from Litter & Waste to Water and Biodiversity. This has meant lots of school visits have been taking place recently to meet with Green School Committees and talks to classes.

COMMUNITY CLEAN-UPS

Waterford City & County Council facilitates community clean ups throughout the year to clean up litter and illegally dumped waste from approach roads, local beauty spots, beaches and general public areas. The Environment Department continue to supply bags, gloves and litter pickers to many of the groups taking part, distributing them from both our Dungarvan and Waterford offices. Collection of any bags of litter is then organised for after the clean-up takes place. National Spring Clean takes place throughout the month of April. Registrations are now being taken at

www.nationalspringclean.org As part of this the Environment Department supply bags, gloves and litter pickers to many of the groups taking part, as well as collecting the bags of litter for all clean ups. Groups are encouraged to register their clean up as a National Spring Clean event to receive additional resources from An Taisce.


WORKSHOPS
