COMPULSORY PURCHASE ORDER AS PROVIDED FOR BY SECTION 76
OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966
AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960
AND AMENDED BY THE PLANNING AND DEVELOPMENT ACT, 2000, AS AMENDED
LOCAL GOVERNMENT (IRELAND) ACT, 1898: LOCAL GOVERNMENT ACTS, 1925 TO 2014
LOCAL GOVERNMENT (NO. 2) ACT, 1960
HOUSING ACTS, 1966 AND 1996
ROADS ACT, 1993

WHEREAS in pursuance of section 10 of the Local Government (No. 2) Act, 1960 as substituted by section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Roads Act, 1993 and by the Planning and Development Act 2000, as amended, the Waterford City & County Council of City Hall, The Mall, Waterford (hereinafter referred to as "the Council"), has decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966:

NOW THEREFORE it is hereby ordered that –

1. Subject to the provisions of this order, the local authority are hereby authorised –

to acquire compulsorily the land described in the Schedule hereto for the purposes of strictly managing the site in order to adhere to licence conditions imposed by the E.P.A at Dungarvan Landfill, Co. Waterford, which land is shown on a map marked Waterford City & County Council Dungarvan Landfill, Co. Waterford, Compulsory Purchase Order 2024, (No. 1) and sealed with the seal of the Council and deposited at the offices of the Council (hereinafter referred to as the "deposited map").

- 2. The lands are described in the Schedule II hereto and coloured grey and edged red on the said map is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
- 3. Subject to any necessary adaptations, the provisions of –
- (a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
- (b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development ) Act, 1963 (as applied by section 265(3) of the Planning and Development Act, 2000), as modified by the Third Schedule to the Housing Act, 1966, are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.
- 4. This Order may be cited as the Waterford City & County Council, Dungarvan Landfill, Co. Waterford, Waterford Compulsory Purchase Order 2024 No.1.
