Supporting Waterford Communities Fund 2026

Waterford City and County Council is committed to encouraging communities and empowering residents to make a difference to their areas. To support this, the Council is inviting applications for its **Supporting Waterford Communities Fund 2026**.

The Supporting Waterford Communities Fund provides a contribution towards costs of Residents Associations, Community Groups, Sports Clubs and other groups/committees engaged in community activity, providing community services or carrying out improvement works at local or county level.

Groups can apply under **one** of 3 funding strands: Residents Association Fund, Community Activity Fund or Sports & Recreation Fund.

Checklist of required Supporting Documentation

All applicants must complete the online application form and provide the required supporting documentation by the **deadline of 4.00pm on Friday, 23rd January 2026**. Incomplete or late applications will not be considered, all supporting documentation must be uploaded with the application form before the deadline, otherwise the application will be deemed ineligible.

All groups **are required** to provide the following supporting documentation with their application:

Groups can apply under **one** of the following 3 funding strands:

1. Residents Association Fund

This strand provides a contribution towards the costs of resident's associations, groups or committees who are engaged in community activity, or carrying out improvement works within their own estates/ neighbourhoods/ areas, for:

- Provision and maintenance of green areas.
- Contribution towards insurance costs and ongoing operational costs of resident's association activity.
- Provision of pollinator friendly flower beds, shrubs, trees etc.
- Organised Community Clean-ups or Fun days/ Sports Days etc.
- Projects ensuring natural resources (e.g. rivers, forests, wetlands etc) are protected and enhanced through biodiversity planning, native tree planting etc.
- Improvement projects to areas of historical/ cultural nature.

2. Community Activity Fund

The Community Activity Fund aims to assist communities or a combination of communities, to work together to develop a local plan for their own area(s), to establish sustainable structures enabling communities to identify and meet their own needs – “helping them to help themselves”. The Fund can also be used to up-grade or replace equipment. The type of projects that can be funded include:

- Activities /events to promote innovative communication to improve community engagement and encourage participation towards establishing a local development plan for the area.
- Activities / events that bring different areas or communities together to help plan the future of such communities.
- Repairs / Tools/utensils.
- Room hire / Transport costs / Insurance.
- Community events/productions.

3. Sports & Recreation Fund

This strand aids Sports Clubs and Recreational Organisations who are engaged in community activity, providing sports opportunities across all ages and abilities. It aims to assist Sports Clubs provide or improve the range of Sport and Leisure opportunities to Waterford's Communities.

Funds are available for:

- The purchase of sports equipment that has a positive impact on the level or quality of sports participation within the club e.g. bibs, balls, cones, fitness equipment, etc.
- Room hire/ Transport costs / Insurance.
- Sports Specific Coach Education.

- Accredited courses run by the Irish Sports Council (ISC), Coaching Ireland or National Governing Body of Sport.
- Referee, umpire or official accreditation.

The above lists are not exhaustive and works other than those specified may qualify for grant assistance. It has been prepared to give a flavour of the kind of things that the fund will support.

The Supporting Waterford Community Fund provides small scale grants to community groups. For reference purposes, the grants awarded in 2025 are set out below. 2026 grants will be dependent on the number of eligible applications received:

- Residents Groups - €880
- Community Groups - €762
- Sports Groups - €762

Scheme Information

- Applicants can only apply/qualify for funding under one Supporting Waterford Communities Fund 2026 strand.
- Groups/Organisations are required to be registered with the Waterford Public Participation Network (PPN) and to provide their unique PPN number.
- Supporting Waterford Communities Fund 2026 allocations will be distributed as equitably as possible across the Metropolitan, Comeragh and Dungarvan / Lismore areas of Waterford.
- Where Groups / organisations have received previous community funding from the Council (e.g. Supporting Waterford, Local Enhancement Fund etc) and have not provided the required proof of payment (receipts / Invoices and Bank Statements) by the deadline outlined in their letter of offer, they will not be eligible to apply for the Supporting Waterford Communities Fund 2026 or future community funding.
- In the event of the Scheme being oversubscribed, applicants may not receive the full amount applied for.
- Preference will be given to organisations who have not received any support from Waterford City & County Council grant schemes previously.
- Projects are encouraged to access other sources of match funding as part of the project total budget.

Requirements where applications are successful

- If successful, proof of expenditure in the form of receipts is required. In cases where groups only receive invoices from suppliers, the invoices must be marked 'paid' and a bank statement clearly highlighting the expenditure must be provided. For purchases made using cash, receipts are required. In cases where groups only receive invoices from suppliers, email / letter on headed paper confirmation from suppliers stating the amounts

and dates payments were received must be provided. The payment confirmation must include the suppliers' contact details.

- Proof of Expenditure (receipts / invoices and Bank Statements etc) must be provided before the deadline, as set out in their Letter of Offer.

Low Carbon and Sustainable projects

Waterford City & County Council is aiming to reduce emissions by 51% by 2030 and by the end of 2050 be a fully climate resilient, biodiversity rich, environmentally sustainable and climate neutral economy. Groups should consider the climate and environmental impact of their projects and where possible ensure they are low carbon and sustainable.

Examples of considerations include but are not limited to:

- awareness and capacity building (e.g. public information events on climate change).
- shifting to active travel (e.g. walking and cycling), public transport or car sharing to events.
- reducing the amount of food and plastic waste produced and/or incorporating ways to repurpose waste as part of the project (e.g. upcycling furniture, reusing materials etc).
- ensuring natural resources (e.g. rivers, forest, wetlands etc.) are protected and enhanced (e.g., biodiversity planting, wetland restoration, tree planting etc).
- using renewable energy (e.g. solar, wind etc.) over fossil fuels (e.g. oil, gas, coal etc.) and improving energy efficiency (e.g. insulate buildings, choosing A-rated appliances etc).

Who can apply

The Supporting Waterford Communities Fund 2026 is open to all community groups / voluntary groups / Residents Associations / Sports Clubs that meet the following criteria:

Eligibility Criteria and Requirements

Important – Please read the eligibility criteria and requirements below carefully to ensure that your Group / Organisation is eligible to apply for this grant and has the required supporting documentation.

1. Only one application allowed per group, sports club or housing estate.
2. Please note that **incomplete applications shall be deemed invalid**.
3. Applications and all supporting documentation must be received within the set deadline of 4.00pm on Friday, 23rd January 2026. **Late applications will not be accepted.**
4. To be considered for this and future community grants, groups / organisations must be registered with the **Waterford Public Participation Network (PPN)**. Your unique PPN number must be provided when applying for this fund. If you haven't done so already, it is advised you register with the PPN as soon as possible. 5. Applying Groups/committees/organisations must be formally constituted i.e., hold an A.G.M. and have regular meetings. A copy of the **minutes of a recent committee meeting must be** submitted with application.
6. Group/organisations receiving an allocation **must have** a bank/credit union account in their own groups name. **Applicants will not be able to use an umbrella account.**
7. Applicants **must provide** evidence of relevant policies/safeguards if the funding will be used in relation to children, young people or vulnerable adults.
8. Applicants of the Supporting Waterford Communities Fund 2026 must be **based in the county of Waterford** and beneficiaries of the Fund should be living within Waterford city / county.
9. Applications from ‘not for profit’ clubs or organisations that are open to public membership are eligible for the Supporting Waterford Communities Fund 2026.
10. Organisations whose activities involve intentional harm to animals, or which conflict with recognised animal welfare principles, are not eligible to apply.
11. For profit groups, commercial organisations and private facility owners are ineligible to apply for the Supporting Waterford Communities Fund 2026.
12. Applicants who occupy Waterford City & County Council owed facilities must have a **valid licence or lease** from the Council, which **must be** submitted with their application, where appropriate.
13. All applicants **must** submit a copy of their **end of year bank/credit union or post office account statement.** To allow applicants with over €5,000 in their account to be eligible to apply, applicants will need to provide additional information on source of funds in account in support of their application and to why the funding is required. Final decision on the application will be at the discretion of the council.
14. Applying Sports Clubs must provide evidence of their affiliation to an ISC recognised National Governing Body of Sport.
15. Once you have completed your online application form you will receive an email requesting your signature verification. Please ensure you verify your signature, or your application will be ineligible. Please see pages 7-9 of this document for guidance on submitting your online application.

How to apply

All applicants must complete the online application form and provide the required supporting documentation on the Council’s online platform. If any groups are having difficulty with this, please contact the Community Grants Section of the Council at communitygrants@waterfordcouncil.ie
