7. **Uploaded Community Progress Report for questions:**

7.1 **Community Integration Forum – Noeleen Osborne:**

Waterford Council's Ukrainian Team working with arrivals to the Designated Accommodation Centre (DAC) has now concluded and the building has been returned to owners. New pledge properties are now offered to the other DACs and the team will work with DAC staff to ensure occupancy of properties and management of the licenses going forward. Local Authority Integration Team (LAIT):

For April the Local Authority Integration Team carried out 15 Engagements including 6 information sessions with 45 attendees. There were also 18 non-clinic queries. Main topics covered were Adult Education, CV preparation, Job Searching, Sports Clubs, Potential Workshop Ideas, Needs of those residing in IPAS, Information on Repatriation for a deceased Ukrainian Minor.

As of 11th April, there are 3,154 BOTPs (increase of 10) and as of 6th April there are 636 IPAs in Waterford. Facebook engagement continued and the May newsletter has been sent to all interested parties.

In April the LAIT attended The Connecting Communities Roadshow in Kilmacthomas and also attended the Carlow Council one stop roadshow.

7.2 Social Inclusion and Community Activation Programme (SICAP)– Ger Mulhall

Work is ongoing with Waterford Area Partnership (WAP), who continue to implement the SICAP Programme on behalf of the LCDC.

- Social Enterprise Development Worker (part-time) has commenced to support local communities including the development of a Repair Café in Larchville & Lisduggan Communities based on the outcomes of the TASC People's Transition 2024 report.

7.3 Local Enhancement Programme (LEP) Grants 2025

The Local Enhancement Programme 2025 is funded by the Department of Rural and Community Development. The final list was sent to the Department for approval on the 3rd of April. All applicants will be advised once final approval is received from the Department, which we anticipate should be in late May / early June.

7.4 Community Grants Update – Claire Flavin

Community Recognition Fund (CRF) 2024:

Window 1 (€491,392): One of the seven projects are now complete.

A further three interim claims were received from projects and were processed.

The remaining projects are proceeding.

Window 2 (€86,557): A Letter of Offer has issued to the project approved under Window 2.

Window 3 (€786,625): Seven applications were recommended for approval to the Department of Rural and Community Development for Window 3. We await approval by the Department.

Local Enhancement Programme (LEP) Grants 2025

Supporting Waterford Communities Grant (non LCDC grant)

Waterford City and Council's Supporting Waterford Fund budget for 2025 is €240,338 was approved by the Plenary Council held on 10th April. Total applications received: 318 applications (98 from Sports Clubs, 94 from Residents Groups and 126 from Community Groups) of which 305 were valid. Allocations were distributed as follows:

Residents Association Fund: Number of Applications – 94 (90 eligible) - Allocation €78,990

Recommend that Applications under Residents Association Fund receive €880 allocation

Community Activity Fund: Number of Applications – 126 (122 eligible) - Allocation €91,249

Recommend that applications to the Community Activity Fund receive €762 allocation

Sport & Recreation Fund: Number of Applications – 98 (93 eligible) - Allocation €70,109

Recommend that applications to the Sport & Recreation Fund receive €762 allocation

8. Proposed Waterford Roma Health & Accommodation:

Proposal: Roma Health & Accommodation Pilot Project - Waterford

We have been approached by the HSE and Waterford Area Partnership with a proposed Roma Health & Accommodation Pilot Project. HSE Social Inclusion Dublin and South East have allocated once-off funding of 60K to Waterford Area Partnership for the Waterford Roma Health & Accommodation Project. This funding has come from a HSE National Social Inclusion Office funding initiative to improve the health outcomes of excluded and vulnerable groups living in insecure and/or unsuitable housing.

The overall aim of the project is to improve health outcomes for the Roma population here in Waterford, of which there are estimated to be 800 (315 in Tipperary). This Roma Project will seek to build on the relationships and collaborative work already taking place in Waterford between key stakeholders. There are various strands of actions with the 3 main actions being to

1. ***Undertake a housing needs assessment and deliver advocacy supports to Roma (to be done by WAP)***
2. ***Use the public sector equality and human rights duty as a lever to address Roma health and accommodation needs,***
3. ***Evaluate outcomes, document issues and disseminate learning,***

As part of the pilot a working group of key stakeholders is required to oversee the Roma Health & Accommodation Project strands with Waterford Council, the HSE and WAP committed and the relevant sections of Waterford Council will sit on the working group.

Given the LCDC brief in Health & Wellbeing, social inclusion and migrant integration, we are looking at the possibility of the working group sitting under the existing LCDC framework to form a sub-group of the LCDC to oversee the project strands, so are looking for the LCDC's members thoughts on same and if anyone has an interest in being a part of the sub-group, to make contact with Sinéad. It is hoped to have the sub-group set up by the end of the summer.

More details on the project will be added to the extranet and any interested parties can make contact with Sinéad directly. The proposal to set up the group as a sub-group of the LCDC was passed.
