I am writing to you today regarding your correspondence on behalf of the Members of Waterford City & County Council, regarding a request for the urgent inclusion of Bonmahon WWTP in the Capital Invesment plan.

Your Uisce Éireann reference number for same was 35605.

I am pleased to advise that my colleagues in our Asset management Team at Uisce Éireann have reviewed your query and the following response has become available:

Waterford City and County Council ranked Bunmahon at number 4 in terms of priority on the list of candidate settlements included under the Uisce Eireann Small Towns and Villages Growth Programme for County Waterford.

This ranking was confirmed in 2023. Lemybrien was ranked No.1 and work is currently underway on this project. Based on the prioritisation of investment required nationally and the funding available, Bunmahon is not included in our investment plans for the period 2025-2029.

We continue to engage with Local Authorities nationally and should any site to be reprioritised under the Small Towns and Villages Growth programme they could be considered under the 2025-2029 Investment Plan if additional funding becomes available for this programme.

In terms of ongoing operations, a caretaker inspects the septic tanks in Bonmahon 3 times each week. Sludge levels are monitored on these visits and contractors are engaged when desludging is needed.
