



## SÍNTIÚIS PHOLAITÍOCHTA TRÍÚ PÁIRTÍ

Tá forálacha an Achta um Thoghcháin Áitiúla [Síntiúis agus Caiteachas a Nochtadh] 1999 arna leasú i ndáil le tríú páirtithe ceaptha chun an duine nó na daoine sin a thabhairt faoi réim an chórais síntiúis polaitíochta atá i bhfeidhm ar leibhéal an rialtais áitiúil.

Ceanglaítear ar thríú páirtí a fhaigheann síntiúis airgid os cionn €100 clárú lena n-údarás áitiúil, cuntas síntiúis polaitíochta a oscailt agus ráiteas airgeadais mar aon le deimhniú agus dearbhú reachtúil a chur faoi bhráid a n-údarás áitiúil tráth nach déanaí ná an 31 Márta gach bliain.

Sainmhínear “tríú páirtí” sa reachtaíocht mar aon duine, seachas páirtí polaitíochta atá cláraithe i gClár na bPáirtithe Polaitíochta faoi Chuid III den Acht Toghcháin 1992 nó iarrthóir i dtoghchán, a ghlacann, i mbliain ar leith, le síntiúis ar mó a luach ná €100.

### **Is é an 31 Márta 2023 an dáta deiridh chun Síntiúis Pholaitíochta ó Thríú Páirtithe a thuairisciú.**

## THIRD PARTY POLITICAL DONATIONS

The provisions of the Local Elections [Disclosure of Donations and Expenditure] Act 1999 as amended in relation to third parties are designed to bring such person or persons within the political donation regime in operation at local government level.

A third party that receives a monetary donation in excess of €100 is required to register with their local authority, to open a political donations account and to submit a financial statement with a certificate and statutory declaration to their local authority not later than March 31st in each year.

A “third party” is defined in the legislation as any person, other than a political party registered in the Register of Political Parties under Part III of the Electoral Act 1992 or a candidate at an election, who accepts, in a particular year, a donation the value of which exceeds €100.

### **The Closing date for reporting of Political Donations by Third Parties is 31st March 2023.**
